We, the undersigned, patrons of the Municipal golf course and frequent users of the roadways leading thereto, respectfully petition your honorable body to direct the Department of Public Works to improve this roadway from the northerly terminus of 26th Street to the Clubhouse.

This short stretch, consisting of only about  $\frac{4}{10}$  of one mile, is exceedingly rough with corrugation and sharp rock projections; and, in addition, there is the usual dust nuisance. It can be improved by surfacing with a very inexpensive type of desert mix or other suitable material. Traffic alone justifies the improvement; aside from the fine golf course and beautiful club house - a very important tourist attraction and a creditable pride to the City of San Diego.
