Rita presented the written statement from Craig stating that the plans are still the same as last presentation. Looking for permits within 60 days. Site grading may begin after permit received, within 3-6 months. The first buildings will be built the farthest downhill or the northern most side of the property.

A. Rue Chantemar Storm Drain Site Development Permit, Project 409866 (W. Meredith, A. Nazareno, City of San Diego)

The Existing 54 inch corrugated metal pipe drain failed and caused erosion of the slope. Plans are to take out pipe and replace with RTV pipe, adding a headwall, a couple cleanouts, restore slope, add new tough basin. Showed proposed staging area for contractor parking. The plan is to break ground tentatively scheduled for January 2016.

B. Site Development Permit, 11275 Beeler Canyon.

Request to look at process 3 ministerial to approve building permit, to build a 2300-2800 sq.ft. ranch style home on a 2 acre lot, on south side of Beeler Canyon in Scripps Ranch. We have 3 parks with reused water (purple pipe).
