  - A. Speed limit increases on Avenida Magnifica, Carroll Canyon Road, Stonebridge Parkway Avenida Magnifica: Issue of Avenida Magnifica from 25 to 30 between Pomerado and Semillon, both directions. Motion/2nd 'Support keeping the speed limit at 25mph' Ilko/Sorensen, Unanimous PASS Speed limit increases on Carroll Canyon Road, Stonebridge Parkway Carroll Canyon Rd: from 35 to 40 between I-15 and Scripps Ranch Blvd, both directions.

Stonebridge Parkway: Request from resident not to oppose speed increases.

B. Cost of Service Study. Brent Edison, Program Manager, San Diego Public Utilities.

The City of San Diego's Public Utilities Department has recently conducted a thorough cost of service review for water and recycled water services. This review has resulted in a rate increase recommendation which are scheduled to be heard by the San Diego City Council in November 2015. The Public Utilities Department would appreciate the opportunity to make a presentation to your organization about the rate proposal, including the reasons for the increases; the impacts on customers; and the process in which you, as a customer, can participate in the Council decision.

Experts looked at the financial requirements to run the water and waste water services. Concerns arose about the reliability of our water supply, conservation efforts that are state mandated, and investing in Pure Water enterprise. 90% of our water comes from two different agencies that have raised their rates. The cost of desalinated water is more expensive than water from other sources. Potable Reuse is the Pure Water enterprise, which cost less than the other two sources like desalination and purple pipe water. Recommendations from this study suggest increase in rates due to increase from two agencies, desalinated plant. There has been a 43% reduction in water main breaks. Credit worthiness mandates that your financial outlook must be strong. Current estimate of \$1700 per acre foot with projections to continue to increase in the future. New treatment facility off Miramar Road and by 2035 a new reservoir. The largest percentage of the budget, 36% is just to buy water, the next highest is capital improvement projects and contracts to deliver water. Our ongoing debt approximately \$68million per year. Rate proposal of 9.8% in January 2016. A single family residential customer uses about 1200 cubic feet per month, which amounts to \$6.40 increase per month. Reviewed Protest Vote form. On the 17Nov at 10am, the City Council will take a vote on this issue, after receiving and tallying all of the votes from customers.

**D.** The Glen at Scripps Ranch-Final Vote on Recommendation to Planning Commission and City Council. (Oling-Sisay Recused) Various members of the community spoke in support of the project.

Motion to Recommend to the San Diego Planning Commission and San Diego City Council APPROVAL of : <u>THE GLEN AT SCRIPPS RANCH</u>: COMMUNITY PLAN AMENDMENT to re-designate the site from University to Institutional use and add a recommendation in the Scripps Miramar Ranch Community Plan to accommodate a continuing care retirement community at this specific site, a CONDITIONAL USE PERMIT, PLANNED DEVELOPMENT PERMIT, SITE DEVELOPMENT PERMIT, VESTING TENTATIVE MAP, NEIGHBORHOOD DEVELOPMENT PERMIT, and a MULTI-HABITAT PLANNING AREA BOUNDARY LINE ADJUSTMENT to amend Conditional Use Permit No. 133-PC construct a continuing care retirement community consisting of 400 non-acute assisted living units, 50 acute assisted living units (16 of which are memory care units), and 60 skilled nursing beds. and to Recommend the Planning Commission and City Council adopt the following Recommendations and Conditions on approval:

- 1. The Glen's Full Time Equivalent (FTE) allocation of AIU CUP 133 is 550 as a result of the transfer of acreage to The Glen..
- 2. The two monument signs on the southeast and southwest corners of the Chabad Driveway will have the same style. The southeast sign should indicate both the Glen and the Chabad complex, while the southwest sign will indicate the Glen.
- 3. The street name of the current Chabad Center Driveway should be changed to "Campus Center Drive".
- 4. The applicant should construct a sidewalk on the east side of Chabad Drive.
- 5. The Chabad Driveway should be widened so that vehicles turning right on Pomerado Road do not trip the left-lane sensor and activate the signal to stop traffic on Pomerado Road.
- 6. The applicant agrees to save or plant approximately 20 trees along Carroll Canyon Creek, relocate a drainage basin and reslope. The Applicant agrees to maintain fire safety in the open space along Pomerado Road and Chabad Center Driveway.
- 7. The applicant agrees to work with the community for a pedestrian "Campus Trail" link from the Chabad Driveway through to Marshall Middle School.
- 8. As stated in the final EIR Section 4.2, the project will provide shuttles for routine resident trips to reduce peak hour traffic in the community, and will schedule employee work shifts outside peak hours to the maximum extent possible to reduce traffic impacts.
