**Citygate Report on Fire Station Funding**-San Diego City Council President Pro Tem Marti Emerald discussed the Citygate report's finding that the San Diego City Fire Department needs to build more fire stations in order to decrease response time. Presentations were made by Marti Emerald, Deputy Chief Steve Wright and Alan Arrollado, San Diego City Fire Fighters Local 145 President. Included in the presentation was a discussion about building a new fire station located on city-owned property at the end of Encino Avenue. Nick Romero made the motion to approve the program as presented with the exception that the Serra Mesa site be presented to the Serra Mesa Planning Group before being approved by the city. Motion seconded by Rochelle Freeman-Zuniga. Vote: 7-0-0.

**Serra Mesa-Kearny Mesa Library Solar Project**-James Chen and Bryan Olson, both from the Environmental Services Department of the City of San Diego-gave a presentation on the plans to install solar panels in the library's parking lot.
