1. CALL TO ORDER

a. Meeting called to order at 10:35 am with Board Members Cooluris, Crisci, Hank, Landon, Martinez, Ringler and Sieglen-Perry Present. Chapman and Miles not present.

2. PUBLIC COMMENT

a. Kristi Fenick - Introduced herself as District Manager of Park and Recreation's Therapeutic Recreation Services division. She oversees therapy recreation services and senior services programing. Sieglen-Perry asked about the new Park De La Cruz; Ms. Fenick responded it is on the March 22nd Council docket for CDBG funding approval and is expected to open in December 2017.

3. APPROVAL OF MEETING MINUTES

Motion by Hank, Second by Landon, to approve minutes of February 18, 2016. Approved 6-1-0 (yay: Cooluris, Hank, Landon, Martinez, Ringler and Sieglen-Perry; nay: none; abstain: Crisci).

4. EXECUTIVE DIRECTOR'S REPORT

- a. Brown Act Agenda Requirements Due to Brown Act requirements, Thyme suggested the Board replace "New Business" with "Board Recommendations for Future Agenda Items" on all future agendas.
- b. Parkade undergoing automation- DSD will plan check for pay station clearances. To accommodate individuals with hearing loss who push help button on kiosk, procedure in place that receiver of call will remotely open gate after second silent call is received.

 Board asked if push button on ticket and pay kiosks can be larger, thus easier to push.

Creation of Special Event in October 2016 Awareness Event was recommended for October in the Concourse Breezeway on a day not already booked for a similar event and not during legislative recess. Recommended an ADA project, City announcement, or other type of press-worthy event coincide with the event. Other events already scheduled for October 2016 are Jobtoberfest (October 4), Deaf Awareness Day (October 8), White Cane Day (October 15), and Trisomy Day (October 21).
