Information Item: Presentation on the upcoming March 2016 Kensington Talmadge Planning Group elections. Seven positions will be up for election. To run for election, candidates must have attended two full board meetings of the Kensington Talmadge Planning Group between February 1, 2015 and January 31, 2016; and be eighteen years or older; a resident, property owner, or business/non-profit owner or operator within the boundaries of the KTPG.

#### B. Project Review (7:00 – 30 min)

Chair: Ann Pease

Action Item: Approve/Disapprove subcommittee recommendation on the installation of a Vietnamese heritage flag in the center median of El Cajon Blvd at Fairmount Ave. The subcommittee recommended: “Not to support locating the heritage flag at the proposed site, which is outside the Little Saigon district. However, we do support a single flag close to the center of the district, near Menlo and El Cajon Blvd., or slightly to the west. We believe this location would be more appropriate as it is a center of pedestrian activity, and the flag, along with a planned open air market, could become a catalyst for improvements needed in the

area. This site would also allow for the inclusion of educational information explaining the flag and the history of the Vietnamese community in San Diego.”

C. CIP & Planning (7:30 – 15 min)

Chair: Deborah Sharpe

Action Item: The planning group may make a recommendation on Item #17 of the 10<sup>th</sup> Update of the Land Development Code. Item #17 eliminates the City’s existing right to request improvements in the public right-of-way when tenant improvements of more than \$50,000 are permitted for multi-family residential or commercial structures. This issue was not heard at subcommittee. Any motion will require a maker and a second.
