XII. Information Item:

a. Port of San Diego presentation on two Barrio Logan Projects:

i. Cesar Chavez Park Lighting of grass field \$189,000. Community concerns were raised over hours of operation and light pollution.

- ii. Cesar Chavez Pier activation to provide benches, tables, shade structure and lighting at the end and along the length of the pier, \$110,000. Community concerns were raised over the shade structure blocking the views out on the Fourth of July. The lack of specificity of the furniture as it relates to the historical accomplishment of connecting Chicano Park to the Bay. That the furniture was to evenly spaced and prevented larger gatherings.
- Family Health Clinics has purchased 4 properties on National Avenue to provide surface parking for their employees and customers, they will bring before Planning Group when projects are developed.
 Community concerns over the loss of small neighborhood houses, landscape and shielding parking from street.
