Please bring the following with you when you come:

- Picture Identification (ID)
- A copy of last year's income tax return(s)
- W-2 form(s) from each employer
- Unemployment Compensation Statements
- All 1099 forms
- All forms indicating federal income tax paid
- Dependent care provider information (name, employer, ID, Social Security number)
- All receipts or canceled checks if itemizing deductions
- Social Security cards or other official documentation for yourself and all dependents
- Spouses filing jointly should both come in.
