7. Staff reports:

A. Elected Official Reports

Mayor's Office, (Ms. Darnisha Hunter)

Indicated the Mayor's Office will be implementing "Think-a-bit" initiative in which he will ask 100 businesses throughout the City to sponsor High School students in developing their employment skills.

City Council D4, (Matthew Gordon)

Indicated Ms. Cole's office (in partnership with the Alpha Project) is working on addressing the homeless and transient population in our District by providing access to social services designed to increase their readiness for employment

C. Civic SD Report: Derek Hull

9. Action items

A. Winnet Residence Development Request for Tentative Map Extension

Presenter: Mr. Miles Cooper, CEA Engineering

Request for a map extension was denied, 5 votes against (Oates, Howell, Pollard Matthews and Dudley) 4 votes in favor, the conversation suggested they need to do more of an outreach into the Encanto neighborhood, specifically "The Encanto Lunch bunch".

B. Bayview Street name change.

Presenter: Harold Tolson, Bayview Baptist Church Request to change the name from Benson St. to "Pastor Timothy J Winters St" The motion passed unanimously



Apparently they have gathered enough signatures, as well as the other requirements of the City to change the name of the street. There was conversation about the length of the name and whether the residents that agreed was aware of the administrative changes each effected residents must do the accommodate the change, change of addresses, at some time for Drivers licenses, Insurance, utility Bills, etc.

10. Information items:

A. Groundworks Urban Greening Project

Presenter: Joel Cramer, Groundworks

Discussed and updated the group on Groundworks activity which included the Encanto Canyon restoration Project just east of the MLX library; Emerald Hills restoration. Activities included Open space trails, Urban Trails, Trail closures kiosks and habitat enhancement.

B. ENCPG Election

Presenter; Ken Malbrough

Mr. Malbrough explained the process ad outlined the positions that are going to be available; Broadway Heights, Chollas View Emerald Hills Lincoln Park (4) at large seats. Explained that the committee will determine if the incumbents want to run for their seats again, outreach into the community, targeted time frame of the election in April/March time frame. Chairperson of the committee is Kwame Oates, and Ed Howell is the additional committee member.

C. Civic SD, Imperial Corridor Master Plan.

Presenter; Derek Hull

Discussion was centered around Phase 1 of the 2005 Imperial Corridor Master Plan. Outlined the plans to include "Way finders" signage outlining major local destinations. Street furniture, trashcans, bicycle racks and benches around certain bus stops benches. Additionally, the chain fence along Euclid and Churchward will be replaced with a wrought iron type fence; the plaza will continue to be updated with different phases based on the Imp. Corridor Master Plan.

Additionally, we all voted on choices for a picture on one of the "way finders" signs in Lincoln Park. Our choices were pictures of St. Rita's Catholic Church, Lincoln High School, "Wall of Excellence" or a sign identifying the "Crest", (which is identified as the highest point in our Lincoln Park community, Euclid and Imperial) The voting results are as follows: "Walls of Excellence"
