ITEM #4 PUBLIC INFORMATION UPDATES

- 4.1 Office of Supervisor Dave Roberts Adam Kaye discussed the approval of "Getting to Zero" initiative regarding Aids in San Diego. Initiative directs the Health Department to create a plan for education, testing and treatment. Plan completion is expected in June 2016.
- 4.2 Office of Councilmember Sherri Lightner, First District, City of San Diego -Steve Hadley – presented status of the RFP for the Torrey Hills neighborhood park on the vacant four acres. Projected release of RFP for bids is May 2016.
- 4.3 Community Policing Officer Williams stressed the importance of locking doors and windows to prevent burglaries. Two new portable speed trailers with flashing current speed have arrived at a cost of approximately \$10,000 each and are being utilized.
