- 1. Support/Oppose City Staff proposal to adjust Undergrounding Districts 3CC1 and 3CC2 to combine Kensington Park North with Talmadge Park North; and to combine Kensington Manor with Talmadge Park South. This proposal does not impact the Undergrounding timeline for any of these neighborhoods.
- 2. Support/Oppose allocating the new Kensington Park North/Talmadge Park North for undergrounding.
- 3. Support/Oppose City Staff proposal to adjust the priority in the Undergrounding Master Plan within Kensington to allocate Kensington Park South districts 3AA and 3AA1 in June, and defer allocations for Kensington Heights, Kensington Manor and Talmadge Park South until after the New Master Plan is released.
