#### Item A

Project: PTS 480473 - Dunaway Addition aka "Lerner Residence"

8676 Dunaway Drive APN: 344-113-0900

**Presented by**: Siavash Khajezadeh and Leticia Bonnet, Design Lead Architects

**Description:** Combination building permit for an addition to an existing single-family residence on an 8,394.20 sf lot.

## **Presentation**

- Applicant obtained signatures in support of the project from neighboring residences, committees, and Covenants, Conditions, & Restrictions (CC&R) groups.
- Lot coverage is 2,989 sf where 5,000 sf is allowed
- Project proposes 10 feet and 4 feet for side yard setbacks. Rear is not changing.

Proposed building height is 25 feet.

## Comments:

- Board surprised that given the visible second story that neighbors seem okay with it
- Structural comments are standard from the City
- Board remarked that the 36 percent increase in square footage is based on visible second floor addition
- Board praised the effort by the applicant related to seeking neighborhood support for the project, however the board expressed concern over making a determination that the 2<sup>nd</sup> story given its size would be considered a minor project.
- The board went over the guidelines from Information Bulletin 621 related to minor vs. major projects.

**Motions:** Approve project as a Major Project-Process 3. Donavan/Goese. 2-2-0. First motion failed to receive four affirmative votes for an action.

Second motion was offered: Approve as Minor Project/Process 1. Potter/Weissman. 3-1-0. Second motion failed to receive four affirmative votes for an action.

No other motions were offered. Project Recommendation: No recommendation due to lack of four affirmative votes.

# **Description:**
