Approval of Minutes from Previous Meetings:

Action Items

1) Frank January – Impact fee study. Community has the opportunity to provide a list of priorities in appendix B; taking this to the Infrastructure committee on 9/22 then City Council on 10/18; Handed out document that is to replace what's in the Community plan . This is a document that presents a list of the public facilities that are needed by the community that support the community plan and is the basis for determining the fee that is charged – to increase from \$9,276 then it will be \$12,649. We will have \$24.5 million (growth potential of 2,000 units for this area). The document will be crafted so that the priorities can be changed over time without presenting it to City Council. Planning Committee and Community is being asked to read the document and vote on whether or not they approve the document with a priority list to follow. GGHPC is asking for back up on the line item costs on the Impact Fee projects list.

- Brierton Motion That the GGHPC to put as the highest priority the multi-modal path and the Russ Street improvement; seconded by Hirmez. 9 – yes, 1-no (Davis), 2 abstain (Coneglio, Swarens)
- Santini motion to approve the document ; seconded by Zacarian. Unanimous with 1 abstention
- Chair asks that sub-committee put together a priority list for City. Van Denheuvel and Coneglio volunteered to hold a meeting on Monday 8/15 at 6pm at the bench outside of the Golden Hill Community Recreation Center. January had also agreed to attend meeting.

2) 32nd Street/Huckleberry

Presented by Thinh Tran & Sean Paver – Tran's job is to get access for his crew to access the sewer system in the canyon; project was approved October 2009. Most of the access path has been implemented already. 12 manholes and approximately 3,700 linear feet of sewer lines. Some of them haven't been cleaned since August 2014 because there's no access. Presented plan to access sewers. C Street – entrance has an existing path to manhole but need to remove boulders and replace with removable bollards and put a no parking red zone in front of path; B & 32nd Street has existing path to access 5 manholes but need to trim vegetation and fill crevice in hillside with DG; Work will be starting in September 2016 so they can finish before bird nesting season that starts on Feb 1. Community stressed the importance of taking into consideration that there are people in this community who love the canyon and they ask that their impact is minimal

• Brierton motion: That the Public Utilities Department coordinate on the ground with interested community members (Tercia D'Elgian) on how to minimize impact to natural habitat of canyon while also improving access to manholes. Seconded by Van Denheuvel . Unanimous approval with 1 abstention (Swarens)

3) Kelly Stanko Sr Planner – update on supplemental Regulations for Potential Historic Districts and District Nomination (handed out update and prioritization list). Swarens asks that Staff find some way to look at the buildings that are coming through in the interim – for ex. Building on Cedar. Staff is arguing against designation b/c tile roof is now shingle roof but Staff should work with residents on issues like that to preserve the district ; also some format for community engagement would be good to improve the process instead of just having City Staff and the property owners engaged in it. Historic Review Board will meet on 9/14 at 2:00pm at Golden Hall (in Silver Room) downtown

4) Angled Parking Design – 22nd Street
Coneglio motion to accept Engineer's Plan on angled parking; Van Denheuvel seconded
Unanimous, 1 abstention (Swarens)
Coneglio also noted that 25th & E does qualify for a crosswalk
5) Bernie Turgeon – Sept 15th Planning Committee Meeting ; Sept 14th Formal Action on
Community Plan. GGHPC will see final EIR on 8/31

Chair requested that we put together a sub Committee Ad Hoc to review the plans for the developments on next month's agenda; Santini agreed to oversee Ad Hoc Committee. Meeting will take place on Wednesday 8/31 on the picnic bench in front of the Golden Hill Community Recreation Center at 6:30pm
