- Mayor—asked him to reach out to obtain input. Everyone has a stake in Tourism...city doesn't have money for basic services.
- Finances and facilities—tot 15 and ½ tax. Resources should go to general fund and the citizens should decide how the money is spent. All money goes into general fund—18 to 90million. 50 plus 1 for the vote. Mandatory component. If you want to do certain things...follow the rules the voters set out.
- Tourism financing infrastructure done by hoteliers to do all the development and maintenance.
- Expansion does not need to be contiguous...port wanted a 5-acre park. Port purchased in the tailgate area. The city could subsidize the convention center today. Citizens plan says you can use 2% by hoteliers.
- Convadium—citizen's plan says chargers must pay for stadium out of their own pocket.
- California—Citizen's initiative you do not have to do a CQUA. Document if anyone wants to build on tailgate they must do mitigation as if they are not exempt from CEQA. And it must be done in a public meeting.
- Anyone can sue...measure D goes further than state law. There is no project for convention or stadium. There are a lot of conceptual ideas. Communities represented by Alvarez is that mitigation is done.
- Hoteliers want to take over convention center with no protection for workers, etc....
- Measure D—whoever takes over as outsources must take over all the existing agreements. The only things that an outsourced process
- What happens to mission valley? Chargers says that if the chargers do not get a downtown stadium that they are leaving. If the chargers pay their own way the price charge is current 650million it is probably at 850million.
- If they build all the rules must be in place. www.citizensplan.org
- must go to a public vote if mission valley is up for sale at fair market value it can only be used for open space, recreational, 50 acres of river park and the rest for SDSU. Everything must be a public vote.
- Silent on the Mayors proposal to subsides.
- Measure C says money will go to Chargers--?
- What happens to MTS—no one knows, if they must acquire it they must pay for it at fair market value.
- Who pays—spending limit is 2%. Who pays for reconfiguration of streets, rails, tracks, etc...whoever is
  paying for it must pay for everything.
- Railroad—on 8<sup>th</sup> Ave was closed about 8 years ago and there are snags for reopening it. whoever develops
  the site must pay for everything
- What is in this for Corry—he put in \$200,000 of his own money. He fought convention tax...he gets zero from this.
- Why was Barrio Logan not included in this discussion? Process...
- Capital Gains Exception is why people want to move downtown stadium.
- Property tax transfer can only happen through eminent domain
