As the property owner or interested party, you should know that the Historical Resources Board will hold a public hearing to consider the historical designation of the property located at 2535 Midway Drive.

If the property is designated as a historical resource it will be added to the City of San Diego's Register of Designated Historical Resources. Designation brings with it the responsibility of maintaining the property in accordance with the U.S. Secretary of the Interior's Standards for the Treatment of Historic Properties.

The decision of the Historical Resources Board to designate a property is final unless the designation is appealed to the City Council. In order to appeal the decision of the Historical Resources Board you must be present at the public hearing and file a speaker slip concerning the designation or have expressed interest by writing to the Historical Resources Board before the close of the public hearing. To file an appeal, contact the City Clerk at 202 "C" Street, Second Floor. The appeal must be made within 10 working days of the Historical Resources Board decision. If you wish to challenge the City's action on the above proceedings in court, you may be limited to addressing only those issues you or someone else have raised at the public hearing described in this notice, or written in correspondence to the City at or before the public hearing.

If you have any questions after reviewing this information, contact the HRB staff member listed above.

This information will be made available in alternative formats upon request.
