Hickman Field also had an issue with an aggressive homeless and when the police were called the employees of Hickman Field were told that they needed a Letter of Agency, but since it is city park they didn't need one.

Allen Chan spoke about the homeless populations as well and stated he would help with red lining the area of convoy where there are people parked and living in their vehicles. Also mentioned he would look at making extra resources available to help with this issue.
