Addendum 1a: Action Item VII.1.a, NPMAD becoming a Subcommittee of NPPC

- a. NPMAD April 10, 2017 MOTION: For the NPMAD to join the NPPC, incorporating the bylaw revisions approved at the March 13, 2017 meeting to be a NPPC Subcommittee

Addendum 1b: Action Item VII.1.b, NPMAD Draft Bylaws Recommendations

- a. March 13, 2017 Draft NPMAD Approved Bylaws:

“The following additional provisions apply to the NPPC North Park Maintenance Assessment District Subcommittee (NPMAD):

1. The NPMAD boundaries are identified as “Exhibit ?” of these bylaws.
2. The NPMAD operates under Municipal Code 65.02.01 in addition to these bylaws.
3. The NPMAD shall provide advice to the City of San Diego staff (“City”) on matters relating to the North Park Maintenance Assessment District (“District”) landscape projects, lighting and special community improvements as outlined in the annual Engineer’s Report for the North Park Maintenance Assessment District (“Report”) to the City of San Diego.
4. NPMAD Membership shall consist of a minimum of seven (7), but no more than thirteen (13), representing the following groups and individuals within the District Boundaries:
 - a. North Park Main Street
 - b. North Park Community Association
 - c. North Park Historical Society
 - d. North Park Planning Committee
 - e. Burlingame Neighborhood Association
 - f. El Cajon Boulevard Business Improvement Association
 - g. Altadena Neighborhood Association
 - h. Other North Park Organizations to be determined
 - i. Three at-large resident property homeownersThe aforementioned groups or individuals will submit names to the NPMAD Chair who will forward the list of candidates to the NPPC Chair for NPPC Board confirmation.
5. Appointments are made annually for twelve month terms after the election of NPPC officers at the regular April meeting and before the close of the regular May meeting. NPMAD to appoint replacement of resigning NPMAD members.
6. The NPMAD shall contain at least one currently elected NPPC Board member.
7. The NPMAD Subcommittee Chair will be appointed by the NPPC Chair from any member of the NPMAD.
8. All NPPC Board Members will be eligible to vote of on actions forwarded from the NPMAD, whether they live within the NPMAD Boundaries or not.
9. The NPMAD shall meet regularly on the second Monday of each month at a location within the District boundaries.”

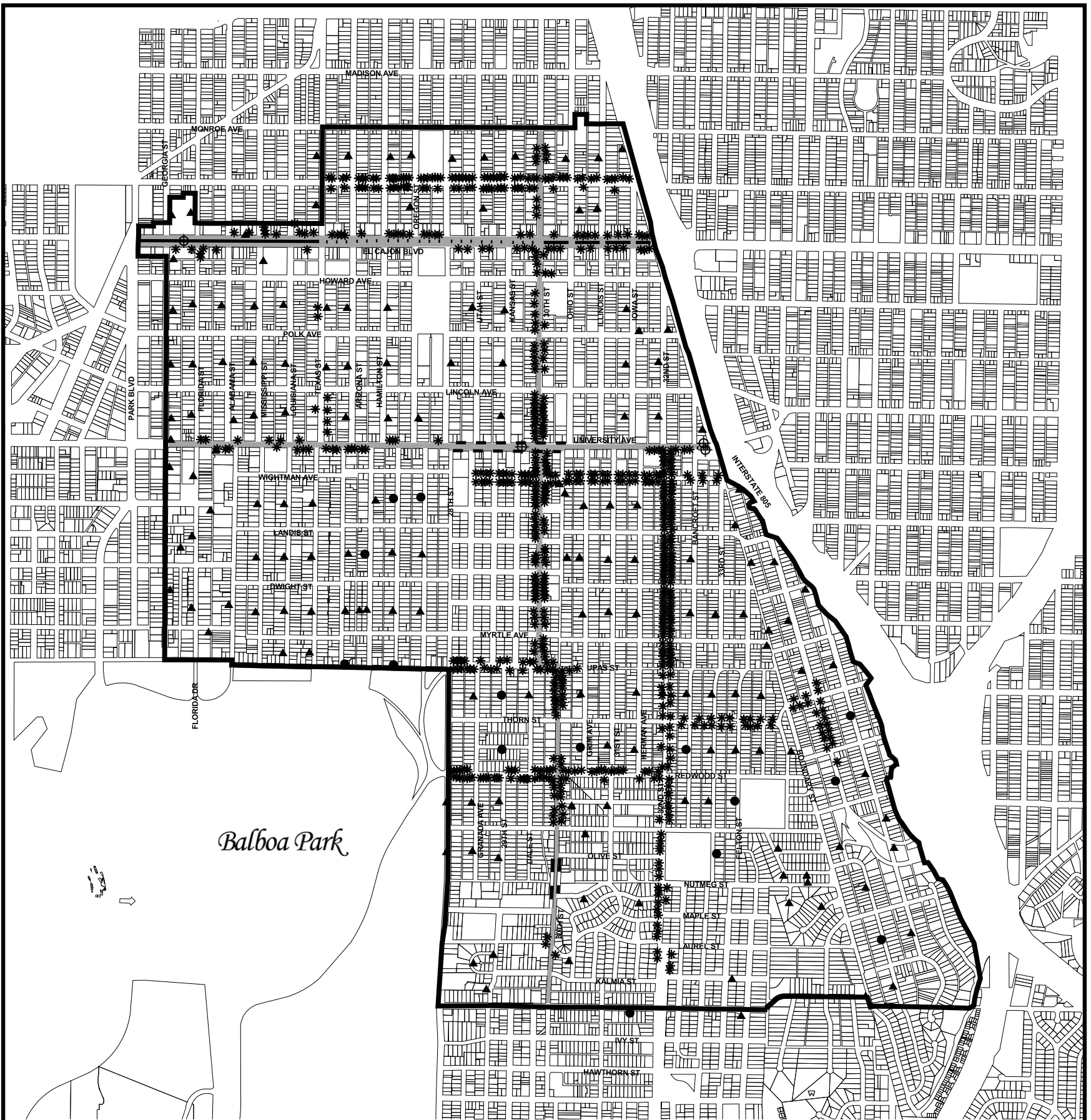


NORTH PARK | MID-CITY BIKEWAYS
