ITEM #1 **Call to order/roll call – special meeting:** The meeting was called to order by Vice-Chair Sherry Guthrie at 6:03 PM. The quorum was met with 11 of 13 members present.

ITEM #2 **Non-agenda public comment:** None

ITEM #3 **Comment Period for Westwood parking restrictions:** As a consequence of new information presented at the April 20, 2017 Planning Board Meeting and subsequent action by the Board, residents will be given an opportunity to comment on the 2-hour parking restriction between 10 PM and 6 AM on Botero Dr., Poblado Rd. between Botero Dr. and Capilla Rd. (inclusive of cul-de-sacs) and Oculito Rd. between Botero Drive and Capilla Rd. (inclusive of cul-de-sacs).

Karen Parlin, President of the Waterbridge HOA, updated the Board on their progress to mitigate the parking shortage in their complex. They have added 8 spaces and are working with the City, architects, and engineers to increase on-site parking. They continue to utilize Facebook to implement stall sharing with residents. The Westwood Club is still non-responsive to Waterbridge’s request to rent some of the club’s parking spaces.

Two Westwood residents were in attendance that do not reside within the petition area expressing concern about the Palomar College project and the impact on their streets.

Vice-Chair Guthrie reiterated this meeting was being held to allow residents in the Westwood community the opportunity to provide dialog about this issue to the Board. The Board originally indicated that while they did not feel the installation of the signs was a viable solution to the problem, they would support the residents. The City requested the Board to either support the petition to add 2-hour parking restriction signs between 10 PM and 6 AM or deny it. As a follow-up to the City’s request, evening drive-by surveys by all members of the Traffic & Safety Committee throughout a one-week period of all the streets listed in the petition, photos showing the available parking on the streets, Police Department license plate checks reflecting the majority of vehicles parked on the streets, were in fact residents of the streets named on the petition, and the City Police Department reporting that the parking restriction could not be enforced. Consequently, the Board voted against the installation of the signs.

ADJOURNMENT: There being no further business, motion Jim Denton, second Dan Grobee to adjourn the meeting at 6:45 PM. The motion passed unanimously 11-0-0.
