5. Staff Reports

- City of San Diego Council District 8 Office – Gabriela Dominguez Distributed a Memorandum from Councilmember Chris Ward regarding “City Council Select Committee on Homelessness Draft FY 2018 Work Plan. The final work plan on the City’s Comprehensive Homeless Council Policy 000-51, established in 1995 will be updated and a final draft will be posted to the Committee website after Committee member feedback and public input are obtained.

Ms. Dominguez discussed the City Council Override of Mayor’s 2018 Budget Veto.

- Port of San Diego – Ron Powell—Not in attendance, however a memo from him was read to the BLPG:

-News on Cesar Chavez Park—Harbor Police John Bolduc and Navy Captain Roy Love, have agreed that towing for parking violators who exceed the 3-hour limit at Cesar Chavez Park will become an enforcement option. It is being done to prevent Navy personnel and waterfront workers from using the park spaces for free parking on weekdays, blocking access to the park for community residents and others.

-Port parking enforcement officers are placing notifications regarding the impending initiative of towing on all vehicles at the park over the next few weeks to get the word out.

-Copies of the warning will also be sent to Capt. Love to share with his Navy team.

-Towing of violators is scheduled to start Monday July 10.

-Towing will occur from 6am to 3pm Monday through Friday.

-There will be no towing on weekends, holidays or after 3pm.

-Towing is last resort. Notices on cars will begin on Friday and build up through July 10.

August 26, 2017 Operation Clean Sweep—looking for volunteers interested in cleaning up the Waterfront. Registration will be on site or pre-registration for groups of 10 or more at SDPTA Office 8/23-24 from 1-4pm. Clean up will take place from 8-11am with an after party taking place at Cesar Chavez Park 11am-11pm.

- State of California, Assemblywoman Lorena Gonzalez-Fletcher – Aida Castaneda—discussed the Diaper Drive as a huge success creating a new Diaper Bank program at Jacobs & Cushman San Diego Food Bank. This will be the last meeting for Aida Castaneda at Assemblywoman Lorena Gonzalez-Fletcher’s Field Representative. She will be attending San Francisco State University in the Fall.

Luis Ojeda provided a plaque to Norene Riveroll for the work she did in guiding the BLA/MAD through the transition, as a project of the Barrio Logan Planning Group.

Chris Zertuche and Miguel from the Logan Avenue Consortium and La Bodega - discussed the Logan Avenue Consortium. The LAC is a grassroots community organization dedicated to promoting cultural events, local artists, and businesses on Historic Logan Ave. Members of the LAC are community leaders, residents, artists, event planners, veterans, and business owners who dedicate their time and energy to their community and ensuring its culture stays relevant in every aspect. On this street you will find a high concentration of creative energy emanating from the many art galleries, eateries, and shops of the LAC. Walking the street delivers a cultural immersion you can't experience anywhere else. The LAC has been the driving force behind this electric feel. Upcoming events such as the bi-monthly Barrio Art Crawl, Latin Jazz Nights at Border X, the Logan Ave. Flea Market, La Vuelta—a bi-weekly showing of low-riders cruising the avenue. On August 26 they will be hosting a large cultural gathering/Barrio Art Crawl and everyone is invited to participate. **It was agreed that the BLPG will provide support for the August street closing and street fair.**
