UPTOWN Capital Improvement Plan (CIP). (ACTION ITEM) Discussion of the CIP list and recommendations for Uptown Planner Board consideration

CIP PRIORITIZATION:

The Public Works Staff is asking for a prioritization list from CPGs in regards to the CIP. Direction regarding this prioritization is provided below.

Important Notes:

- A) Besides prioritizing your Top 5 (1 through 5), all other CIP projects should be re-entered on the CIP survey forms. One project per form.
- B) There is no saving the CIP Survey forms for editing later. Public Works understands that is a defect and hope to solve it in future iterations of this biennial process.

- a. **Review CIP recommendations from 2014**
- b. **Other recommendations to consider:**
 - 1) **Recommendation that Uptown Planners support the use of locally available public funds (UCPD / MAD) for placemaking opportunities associated with the SANDAG bikeway throughout Uptown. These would include the items that Bankers Hill has taken advantage of to date including street trees, landscaping, trash receptacles, lighting and such. This would be supportive of several policies in our community plan.**

2) In response to several recent serious injuries on University Ave (which is a Vision Zero corridor):

a) Consider adding to our CIP list mid-block crossings for University Ave between 10th and Vermont, and another between Vermont and Richmond. These have been advocated for by the community for years now, and is the site of at least one pedestrian death and a recent serious injury.

b) Consider adding to our CIP list a pedestrian crossing at Centre St. and University Ave. This is a very dangerous intersection with no pedestrian markings at all and the site of a recent serious bicycle related incident.

c) Consider adding to our CIP list pedestrian improvements to the Robinson St. Bridge over the 163. It is a very dangerous place for pedestrians to cross the onramp / off-ramp areas.

We will only provide our prioritization for the top five projects. Our recommendation will be provided as a motion at the Sept 5, 2017 Uptown Planners meeting.
