**CPC- Mark Freed:** Marijuana facilities raised general questions as we are not the community. Trying to figure out how to address these requirements. City's website is outdated. Looking from at it form a land use and planning stand point. Not social issues. Going to be a policy in place they are just unsure at this point as to how. Might be additional regulations in place even after the facilities open. **Border Transportation- Alejandra Mier y Teran:** Laurie Berman now Caltrans Statewide Director. Working with MTS for new bus route 909.

La Media Truck Route-Kaitlin Arduino/David Wick: The last meeting at the Mayor's office announced an aerial with over lay with the improvements they are proposing to incorporate into the Capital Improvement Project. Six lanes from 905 S to Airway Five from Airway to South of Siempre Viva and four lanes from Siempre viva to the boarder. Total Project costs 37M does not include any right of ways, but will be given without consideration. Optimistically 3 years from start to finish. Pessimistic 5 years from start to finish. Getting right of ways from each property owner, Engineering drawings from Metropolitan Airpark and environmental mitigation.

La Media West Wetlands- Rob Hixson: No report given.

**San Diego Airport Advisory Committee- Lisa Golden:** Public meeting 5:30 across the street from Otay Nestor Library rounding out the public process comments or questions.

**Code Enforcement:** Reoccurring problem across from Ocean View Hills on the South Side, East of Siempre Viva Property Owner grading permit on his site. Airway just east of La media, illegal grading and truck parking. N of 905 but south of Ocean View Hills Lost are illegal.
