

## **NOTICE for March 18, 2018 ELECTION**

### **ENCANTO NEIGHBORHOODS COMMUNITY PLANNING GROUP (ENCPG)**

**Jacobs' Center, 404 Euclid Avenue, Community Room, San Diego, CA 92114**

**Encanto Neighborhoods Community Planning Group area** is located in Council District Four within the Southeastern San Diego community area. It is predominantly a low-density residential community with the opportunity for denser residential projects, commercial and industrial uses located near major streets and transit hubs. The area is characterized by changes in topography that create some significant views. Transit is alive and present in the Encanto Neighborhoods with San Diego Trolley stations at 47th Street, Euclid Avenue/Market Street and 62nd Street.

**The ENCPG consists of the following neighborhoods:** Alta Vista, Broadway Heights, Chollas View, Emerald Hills, Encanto, Lincoln Park, O'Farrell, and Valencia Park.

**Community Planning Groups** provide citizens with an opportunity for involvement in advising the City Council, the Planning Commission, and other decision-makers on development projects, general or community plan amendments, re-zonings and public facilities. The recommendations of the planning groups are integral components of the planning process, and are highly regarded by the City Council and by staff.

**Neighborhood Seats:** a person must be affiliated with that neighborhood.

**At-Large Seats:** a person must be affiliated with one of the eight neighborhoods: Alta Vista, Broadway Heights, Chollas View, Emerald Hills, Encanto, Lincoln Park, O'Farrell, and Valencia Park

### **MEMBERSHIP BENEFITS OF BELONGING TO ENCPG**

- May run as a candidate for a seat.
- May vote in the election for candidates running for seats and officers.
- May join and serve on subcommittees.

## MEMBERSHIP AND CANDIDATE ELIGIBILITY REQUIREMENTS

To be an eligible community member an individual must be at least 18 years of age.

**Members and Candidates shall be affiliated with the ENCPG community as a:**

1. **Property owner**, who is an individual identified as the sole or partial owner of record, or their designee, of a real property (either developed or undeveloped), within the community planning area, or
2. **Resident**, who is an individual whose primary address of residence is an address in the community planning area, or
3. **Local business** owner or non-profit owner, operator, or designee at a non-residential real property address in the community planning area.

The ENCPG shall require proof of eligibility during elections.

### Meeting Attendance and Application Requirements:

**Community membership:** must attend three meetings and submit an application.

**Candidates for the March 2018 election:** "...must have documented attendance at three meetings of the ENCPG's last 12 meetings prior to the February regular meeting preceding the election." [Article V., Section 1.] They must submit applications for both membership if not a member, and to run as a candidate for a seat.
