#### 6. Staff Reports:


- a. Mayor's Office: Darnisha Hunter not present.
- b. Council District 4: Mathew Gordon not present.
- **c.** Assembly District 79: Lee Hernandez stated there is an upcoming recognition event July 27th and 6th annual health fair on August 11th.
- d. Senate District 39: Chevelle Newell-Tate stated they are partnering with Assemblywoman Weber's office for the health fair & back to school kick off. Chevelle stated budget approved by Governor highlights include homelessness and SDUSD homeless youth services funding. Chevelle stated the Senator is working on a breast cancer awareness bill.
- e. 51 Congressional District: Stephanie Allen not present.
- f. **City Planning**: Elizabeth Dickson stated park staff is currently working on the parks master plan, series of workshops, and people can visit www.cityofsandiegoparksplan.com to participate.
- g. Civic San Diego: Sherry Brooks not present.

#### 9. Informational Items:

- a. SANDAG Projects within the Community Presenter Brian Pollard Urban Collaborative
  - i. Brian Pollard discussed the social equity analysis and how our community often does not get services and resources. Brian asked for community input on specific transportation-related services and resources the community needs.
- b. County of San Diego Southeastern Live Well Center Discussion Presenter Steve Schmidt, Deputy Director of Capital Programs, County of San Diego
  - i. Steve stated he will present the projected plan for the center and plan for obtaining community input. Steve stated the project is scheduled for August 2018 ad for design build services, November 2019 start construction and hope to be completed by September 2021. Steve stated there will be 9 community project design input opportunities through Q2 2019. Steve stated ll county buildings have art components, community input Q1 and after artist selection Q2. Steve stated the County looked at other sites but determined this was the best location & size, and near public transit. Steve stated Wednesday 9am there will be a tour hosted by JCNI ; Saturday, August 18th 9am; July 31st 5-7pm there will be a meeting at Malcolm X Library.
  - ii. Susan stated they want community input for design.
    - A. The general tone from the meeting was anger from lack of transparency from the County/City about this project from the beginning when it was started in 2015. Many opposed the project. Some community members did provide the County with design input they sought.
