1. **Call to Order/Introduction of Members:** Otay Mesa-Nestor Community Planning Group (OMNCPG) Chair Alberto Velasquez called the meeting to order at 6:31 p.m. He welcomed all Board members and members of the community to the meeting.
2. **Approval of minutes:** A motion was made by Patty Swanson to approve the minutes of the September 12, 2018 OMNCPG meeting. Motion approval was unanimous.
3. **Non-Agenda Public Comments:**
 - a. Robert Broomfield requested that the apartments adjacent to the Border to Bayshore Bikeway project are informed of the potential new bike lane.
 - b. Patty Swanson offered thanks to Sam Mendoza (absent) on behalf of his wife, Maria Mendoza, for her many years of service in our community planning group. Maria was a valuable asset to our group. Everyone was saddened by her sudden passing and wanted to convey to Sam our heartfelt condolences for his loss. Our thoughts and prayers are with Sam during this difficult time.

 - a. Officer Lacarra reported that Aida is in training this week, so he will cover the meeting tonight.
 - b. Officer Lacarra brought a flyer on Halloween Safety tips, and asked that it be shared with family and friends.
 - c. He mentioned that transactions from a Craig's List ad need to be done safely. He said it should be conducted in a well-lit place, like a police station, where there will be cameras and lights.
 - d. There was a fatality at a large nearby intersection when a pedestrian did not cross at the corner. The person who hit the individual was not charged, and it was found to be an unfortunate incident.
 - e. The City of San Diego Police Department Academy training will be completed next week, and trainees will be incorporated into the police force.

Informed by several rounds of community input, a preferred route with preliminary design has been developed. Based on community input received at the August 8th meeting of the OMNCPG, concepts for the Oro Vista Road segment of the project were revised.
