 - 50th street and University gathering space for “placemaking” activities

- **Rolando Public Library Parking issue:** library has insufficient parking has rooms that can’t be used because of lack of parking. The community is not able to use it. EACPC to write a letter of support for the parking to be restored to the library. Derryl made the motion to send a letter; Mario 2nd the letter. Unanimous vote by the board.
 - **Review of EACPC Improvement plan currently in place:** Linda passed out paper of priority list for Mid-City facilities financing Plan to see what the community listed as high, medium, and low priority and where the the

neglect has been from the City of San Diego. Chollas comfort station has been listed as shovel ready for years and nothing has ever happened. The Chollas children's parks have been completed, but the City hasn't opened them yet because they need to do some groundwork. How can we be proactive about all of our neighborhood issues?
