#### 3. Review and Approval of Minutes

Motion made by Monte Jones to approve the October minutes. Seconded by Khalada Salaam. Vote: 7-1-2. Motion Carried. Leslie Dudley & Sandi Hazlewood abstained.

### 4. Communications from the Public:

- a. Francine Maxwell asked the board to stop calling the area southeastern San Diego because of the negative connotation.
- b. Kenneth Malbrough stated if anyone wants actions taken, they must email in advance so it can be on agenda. Ken stated 2 weeks before the meeting would be enough advance notice.

#### 5. Chair's Report:

a. Ken Malbrough stated board needs to form an election committee for the upcoming March elections. Shawn Glisson asked if those running can be on the committee, Ken replied no. Leslie Dudley and

b. Ken stated the board needs to decide whether to meet in December or go dark. Sandi suggested we look for an alternate location for 4th Monday in January.

Motion made by Monte Jones to meet in December. Seconded by Sandi Hazlewood. Vote: 7-2-1. Motion Carried. Leslie and Kwame nay.

#### 9. **Informational Items:**

- a. Otay 2nd Phase 1Project: Mike Bajoua
  - i. Mike stated the project is in the final design phase. Mike stated the project is scheduled to start construction in winter 2018 and completed by spring 2020. Mike stated the project will start from south to north on 65th St & Imperial Ave. Mike stated they are upgrading from 36in to 48in pipes. Mike stated they will have traffic control plans and community outreach plans and there will be no right of way acquisition. Sandi Hazlewood asked if this project is being coordinated with the bike lanes project that came to this board months ago. Kwame Oates asked what will be done with the old pipeline? Mike responded that it will be filled with lightweight concrete and slurry will be added on both ends.
- b. AC Water & Sewer Project presented by Santiago Crespo, Project Manager
  - i. Santiago stated they are replacing 990 ft of water main and 138 ft of sewer main. Santiago stated the streets affected are Dominion st, Brooklyn Ave & Madera St. Santiago stated the project will start in fall of 2019 and last about 18 months in total. Santiago stated the contractor will notify community with door hangers.
