1. **Call to Order @6:00**
2. **Roll Call:** all present except Tina Camarillo and Tom Ryan.
3. **Approval of the minutes**
4. **Adoption of the Agenda—Roman Partita-Lopez moved to January meeting**
5. **Staff Reports**
 - City of San Diego Council District 8 Office – Eddie Padilla—Looks forward to working with the BLPG in the future representing Councilmember Vivian Moreno
 - City of San Diego Mayor's Office – Eric Young—not here
 - City of San Diego Planning Department – Elizabeth Ocampo Vivero—not here. Mark Steele said Elizabeth Ocampo Vivero has been asked by the City if we are going to need translation services. We probably will need for the planning document—maybe some half a dozen meetings or so.
 - Port of San Diego – Ron Powell—Reporting on three issues:
 - 1) 12/3—the State Lands Commission adopted an environmental justice plan. EHC played a big role. It is the fair treatment of all people with respect to the development and enforcement of environmental laws and policies. As individuals go forward before the State Lands Commission they will be reviewed by the policy mentioned above. The State Lands Commission is will be hiring someone to go out and educate and act as a liaison to the community focusing on issues that are based on their policy. The Lands Commission is its own entity and is inclusive of other Gubernatorial cabinet members,
 - 2) Shelter Island Boat Launch Ramp (Ron presented a replica of the new Boat Launch in Shelter Island). It has been out of commission since May 2017. It has been renovated. It is a new attraction for families to walk around in addition to the boat launch where people launch their boats. It was a \$10m project by the State Dept of Boating and Waterways and the Coastal Commission. The project was delayed due to the excavation where they found big slabs concrete in the water that has affected the building.
 - 3) Holiday Parade on 12/31 starting on Harbor Drive (County Admin Bldg)—to Sea Port Village. 10 different bands, including 29 large balloons.
 - 4) Larry Hofreiter —Harbor Drive South Multimodal Corridor Study—Update to the BL Community Planning Group. The Planning Dept for Port of San Diego presented:
Ideas: Issues on Parking; Trucks traveling through the community; Virtual Fence (RIF Tags) to be able to follow up with their companies; Marine Highway—a thought might be to use a barge to transport things to avoid Streets, Main Goal in planning process is to get to the point of understanding the issues.
The actual projects being put forward are not there yet. More trees are needed to help clean the air.

Mark—Put together an ad-hoc group made up of EHC members along with a couple of members of the BLPG and NASA—City will support BLPG going forward on the BL Plan, if we can prove we can get along. It was the first meeting to explore our ability to work together, members were given homework to do regarding issues of concern. They will gather again on January 22, 2019. The City Planning Dept will support us going forward. Mark stated that he would like to go public with community workshops in February.

David Moty sent Mark an email that he forwarded to BLPG wanting on an update of what has been accomplished with the BLPG. City auditor asked to assess if Planning Groups are compiling with their responsibilities. There was an issue of absences among members of the BLPG participants, however everyone is aware and are compiling. We are to submit an annual report. Mark already has done a report in the Summer 2018 and will complete an updated annual report by deadline.
