Interview homeless, last year it was over 8,000. Passed ban on Styrofoam. Plastic straws are banned. Office has begun budget discussions starting now for 2020 fiscal years. Deficit is \$28M. Mayor is cutting 3% across all departments. May is when budget season starts. Multimodal path is in this year's budget for design. Prop 68 funds sought for this. Contact the Department of environmental services and Councilmember Ward's office for small businesses who can't meet the requirement to go to non-styrofoam. Asylum seekers will be included in the census count. Is the way it's being counted changing again, 2 to 3 months, 60-80 per day being released into the county, but most have families across the country. They will be counted in the census on the 28th. Victoria says on F street and 22nd, the trash is piling up from people living in their cars and RVs. What can we do to get clean up? If trash is seen on the sidewalk, then use the Get It Done App or website.

Community Relations Police Officer Kevin Vasquez, SDPD:

<u>kvasquez@pd.sandiego.gov</u> vendors in parks are now legal thanks to the state law so there will be an uptick in the area. They will need a food handling permit but SDPD will not be enforcing this since it's a civil issue. Rationale for the law was to legalize a practice that is already happening.

Chair's Report by David Swarens:

AB 216, ballots being mailed out for elections to GGHPC and David is still inquiring and finding out if we can do this but not certain yet.

Permanent supportive housing for each district.

MTS transit routes David checked on and no news on that yet.

Bike routes.

Something about a 16 bed 9 bath unit on 24th that is being marketed as investment.

Vice Chair Report by Kathy Vandenheuvel:

Kathy met with Molly Chase, our councilmember for our District 3 Christopher Ward's Chief of Staff, on December 12, about 20th and B and east mesa precise plan and our community plan for the 20th and B. If the council member proceeds with any development, he will engage with the community.

Other item, attended airport noise advisory committee meeting December 19 updated the quieter home program. Spend 2.7m working with 600 home owners. 1000 units for 525 homeowners on wait list. She emailed me and one interesting fact was 19 curfew violations and 73% of noise complaints came from 19 homes.

Curfews apply to departures only.

New program is called neighborhood equity. IF in the zone of the airport noise, program to allow air conditioning on units since if doors opened the noise goes up.

Action Item 1:

Way finding from November meeting. It's on the website. City of San Diego contacted us because it was on priority list but low. City followed up since its low cost. Howard Blackson from last month helped us with the knowledge. The report is on the website about what we want way finding to look like in our community. Key elements for the nodes in our community were made in the map that Tim made. Who is this way finding for? For bicycles, all types, vehicles, pedestrians. Way finding would be an overlay on the bike system. Oscar asked since this is shovel ready, is the city ready to go? Tim – city reached out to us so they are ready to implement but timeline is not certain. **Motion by Sabrina to approve to send to city staff. Tim seconds, 11 yes 2 no.**

John Kroll – some of these signs are good but not necessary.

Mike Gruby – keep high level look , about points of interest, to stay at that level not signs everywhere.

Gary Roberts – are we doing this because the city is asking us to do this? David – city inquired so we are responding. This is something that doesn't cost much and the city has money to do this, it is lower priority.

Action Item 2:

Bike corridor along 30th street, reviewing recommendations and Mike Gruby says maybe not a good idea to keep the "sharrows" on the 30th after the pipeline replacement project. Sharrows should not be on a dangerous street when a safer street with class II route is a block away. Suggestion is class III sharrows don't need to be in certain places.

Chris Taylor lives on Fern Street. Most important thing is to direct people correctly through the neighborhood. Sharrows need to be there to let drivers know bikes are sharing the lane, the sharrows are not to show where to ride, and it's only to help drivers know. Kathy is in favor of the sharrows and wants to keep them. Tim what is the intention of the work Mike Gruby did? Mike- to start a discussion.

<u>MOTION</u> Kathy ad hoc subcommittee to explore the recommended changed of figure 3-2 existing and planned bicycle networks, Victoria on it as chair. Tim seconds. Susana is on the subcommittee and Chris Taylor volunteers to be on it. 13 yes, unanimous.

Fern and Grape street recommended – west on grape

Sabrina says to remove the deco bike station to increase safety.

It shouldn't take Vicky Granowitz to get hit to make a change for better safety at that intersection.

Mike Gruby says ask city to come to meeting with plans.

David -9 or 10 weeks for city to do some research on this.

4 accidents the last two years at dusk or evening hours here at this intersection.

<u>MOTION</u> by Cheryl: In light of multiple serious accidents involving pedestrians in the crosswalk at this intersection within the last two years, we request that traffic engineering reevaluate the safety of this intersection immediately.
