The College Area Community Council (CACC) and the College Area Community Planning Board (CACPB) are two separate entities with a common board and officers and joint meetings. IV. Public Comments on non-agenda CACPB items None

V. Law Enforcement Reports:

SDSUPD Peterson: 4 arson cases all arrested. During Spring break Officers were paired with social worker to work with homeless. We're hiring.

VI. New Business

A. *Nominations for and vote by the board for officers for 2019.

Chair: Jennings nominated Reynoso,. S: Gregg all in favor Vice Chair: Gregg nominated Jennings, S: Hoeger all in favor

Treasurer: Boyd nominated Putman S: Bevier all in favor Secretary: Hoeger nominated Cottrell S: Jennings all in favor

B. Noticing of three vacancies on the board; call for Nominations & Elections committee to seek qualified candidates.

Reynoso: Election in May for 2 seats expiring 2022, 1 seat expiring 2020. If there are 3 candidates it will be public election, if only 1 candidate, board may be able to elect. Will announce whether general or board election.

C. Presentation and discussion by Sandy Gade Algra regarding proposed ordinance for Designated Children's Play Areas at San Diego playgrounds.

I'm concerned about dangerous items found in children's playground areas in parks, e.g. drug needles. I'm developing a draft ordinance designating portions of playground areas with equipment as "children only". Other cities e.g. New York have such ordinances. Ordinance is stronger than sign stating a rule; it can be enforced. Curfew would not work because adults are in playground areas during the day leaving dangerous items. I'm working with City Attorney to draft ordinance. I have letters of support from several community planning boards & ask for a letter of support from CACPB.

Answers to board questions. If there are no officers to enforce, violation can be reported on *get it done;* no photo required. I don't know how this would apply in joint use parks. It would ban young adults from children's playgrounds; equipment is designed for 2-5 & 5-12 year olds.

Move to send letter of support to move an ordinance forward: Gregg S: Boyd *Jennings:* support the idea but can't agree to letter until we see the written ordinance to know what we are voting for .

Y: 10 N: 4 (Cook, Hoeger, Jennings, Reynoso) A: 0 *Carried

D. Discussion regarding Accessory Companion Unit issues & possible recommendations to the city if allowed under state guidelines

Reynoso: College Area has greatest concentration of CUs in the city. Cities have limited options to regulate them because of the state law, but do have some leeway, e.g. can prohibit CU in street side setback but not other setbacks. One place city does have discretion, is requiring the homeowner live on the property; San Diego decided not to require that so I don't know if we can do anything about that but we can make a list of other areas we'd like regulated, give it to Gomez's office & see what we could push for. I ask for suggestions.

Amerling: I don't oppose CUs but limits are needed; 2 examples show why. 1) 2 story 2500 sf CU. Law limits CUs to 1200sf. This is 1200sf; the rest is enclosed, roofed over patios. The owner will move there & rent front house as a way of splitting lots without paying DIF or other fees city needs. 2) 2 story, 1200 sf CU 5 ft from fence. Many other cities, have restricted CUs. In College Area 87 CU applications since May '17; only 10 by owners living on property. Hoeger: CUs concentrated in College Area pose a parking problem. Unlike a house they can convert the garage without replacing that parking on the lot. With CU cars can be parked anywhere in the front yard. City currently issues 4 permits to CUs with separate addresses meaning 8 permits per lot. That is code violation. It should be 4 B permits per parcel. Reynoso: City should move to limits by parcel not address. Send me lists & proposals. I will send to Councilmember Gomez to explore what can be done & report back.

E. Project Review Committee Informational report on proposed student housing at 6195 Montezuma Rd. at the corner of Campanile.

Emily Gomes, Maximilian Discar and Jennifer Laird presented arguments against the proposed student housing project because it will displace Alpha Delta Chi sorority, a welcoming faith based sorority, not SDSU recognized, which has no other place to live.

Jennings. We've received many letters in opposition, but Project Review committee & CACC do not determine if a project is built. At June CACPB meeting we will ask SDSU, the foundation, the builder & AS to work with the sorority to find new housing,

F. Notice that a Board retreat will be scheduled during April.

VII. Delegate Reports

- A. Community Planners Committee Reynoso.
 - CPC heard regulations for mixed-use developments going to City Council. These closely fit some ideas we have for parts of College Area development. They won't be imposed, but are available for plan updates or community plan amendments.
 - Presentation from *Housing the Next Million*. They are working with community plan updates & have agreed to work with us.
 - Reminder that annual reports are due. We have until May to submit & I will give to board before next meeting when we will approve it.

CACC made donation to the 7 Celtic Nations Pipe Band which played at Hardy School.

VI. New Business

- A. Discussion & update on the status of the community-generated community plan update project including possible funding of \$5,000 for initial analytical research, & other elements. Mike Jenkins, Community plan steering committee member:
 - Steering committee members met with students in city planning class tasked with developing a College Area Ccommunity Plan update, discussed current conditions & shared plan update goals. We're waiting for them to continue work & analysis.
 - We request CACC approve \$5,000 stipend & agreement for 2 student interns to collate class reports & put it all into a package. They will work with us to refine it as starting point for the community plan update. It's a little vague now to allow students room for maximum creativity
 - Montana: exactly what is in the agreement?

 Jenkins: Students will be like independent contractors, working for the corporation (CACC) under steering committee supervision to put class information into report format similar to planning update. We expect work by end of July for steering committee review & final report in September. Interns will earn \$2,500 stipend each; paid monthly, not per hour.
 - M to authorize \$5000 for intern stipends: Amerling S: Gregg
 Montana: Payment should be tied milestones of work completed, not monthly.
 Boyd: Disagreed, they should be paid monthly.
 Jenkins Tthey are not professional consultants, they will be supervised; there is no specified number of hours or time frame, so payment is monthly.
 - Vote: Y: 13, N: 1 (Montana) A: 0 *carried
 - *Reynoso*: Steering committee member Julie Hamilton & I met with County Supervisor Jacob to inform her of plan update project. She offered to help with contacts.
- B. Discussion regarding proposal to appoint a rep to the MTS Citizen's Advisory Committee to advise on a possible sales tax increase for transit improvements.
 Reynoso. Council President Gomez, also MTS chair, is creating a citizens advisory committee on possible sales tax for transit improvements. She requested that Jose or someone on the CACC-PB join the new Citizen's Advisory Committee. No board volunteers

VII. Treasurer's Report (Year end, 3/31/19): Putman

Revenue \$611, (including \$500 reimbursement from Community Planning Group). Revenue was low partly due to membership drive problems, but \$318.64 expenditures was also low so we made money. Total year-end balance, \$26,361.22; DPT fund approximately \$776,719.

 We're helping establish a new community group "Montezuma Triangle" (Montezuma & El
 Cajon from College Ave. to Ralphs). A June 24th organizational meeting is scheduled at library.

IX. Delegate Reports

- A. College Area Public Safety (CARPUS)
 - 1. Concerns about SDPD responses. Hoeger
 - St. Patrick's day had 117.party calls beginning 2:00 p.m., 42 "priority 1"; no SDPD response until 10 p.m. Explanation was that the local department was short 3 officers & didn't expect so much activity (St Patrick's is traditionally a heavy party time). They did not call other areas or SDSUPD for backup.
 - SDPD Data appears to under represent disturbance levels. Twelve First Response Notices
 (FRNs) were reported but no information on how many calls are made to compare to FRNs.
 There are only 12 CAPP'ed houses which seems low given that one year ago there were
 70 CAPP'ed houses.
 - Parking on lawns is still a problem. Eastern refuses to enforce saying they need a list of
 properties grandfathered for such parking, but are not asking for it. Parking division can
 enforce cars blocking drives, sidewalks, but doesn't. These can be submitted on <u>Get It Done</u>
 - 2.Expanded CARPUS Reynoso

This builds on working group a couple years ago, including landlords, managers, SDPD & SDSUPD. Met again in December; good turn out but only 2 property owners. SDPD CRO Steffan agreed to expand CARPUS to such a group & if successful to meet at 4 p. when more can attend. Hoeger agrees to chair NEAC if there is commitment to such a combined group.

X. CACC Member comments.

Bevier. People need to be aware of city proposal to reform community planning boards This will take a lot of discretion away from planning boards..

Reynoso: Board was sent proposal on this topic from CD 7 planning board. Reforms could include such things as council members filling board vacancies by appointment. It will be presented at next CPC meeting where there will be opposition to some items. Read what I sent & if you want comment made at CPC send it to me; I will assure it will get into CPC minutes. You can share with community members who can also send comments.
