Possible Action Item: Support/Do Not Support that the City adopt supplemental Small-Cell (4G/5G) considerations/requirements for installations controlled by the Land Development Code:

1. That planned installations in historic districts and potential historic districts receive in-depth aesthetic considerations to minimize the visual impact on these sensitive districts.
2. That alleys in historic districts and potential historic districts be given priority over street parkways/right-of-ways to minimize the aesthetic impact in these sensitive districts.
3. That the WCF Guidelines be closely tied to the Land Development Code, by incorporating it into the Land Development Code Manual.

4. That the City require communications companies to provide City Staff with a “Master Plan” for small cell installations citywide for evaluation and coordination by City Staff; which if non-proprietary can be shared with community planning groups and the public.
