- 1. Call to Order:** The Meeting was brought to order at 11:35 AM by Jeff Sallen, chair of the Kearny Mesa Planning Group.
- 2. Meeting Minutes:** Copies of the Minutes of the May 2019 meeting were distributed. The minutes were reviewed during the meeting. A motion to approve the minutes was given and the minutes were approved (7-0-1).
- 3. Non-Agenda Public Comments:**
  - David Belanich with HYAA asked for advice on how to deal with homeless around their office. PGM recommended reaching out to police officer Dave Gibson.
- 4. Information Item(s):**
  - Jeff Sallen provided an update on the Kearny Mesa Community Plan Update in behalf of Lisa Lend and extended invitation for the presentation of the mobility study at a meeting on July 24, 2019 at 3 pm at the Planning Department offices at 9485 Aero Drive in the Main Annex.
  - Robert Garcia with the US Census Bureau gave a presentation on "Census 101: What you need to know". Information on the importance of the census and how to participate was provided.
- 5. Action Item(s):**
  - Jeff Sallen provided a copy of the Annual Report of the Kearny Mesa Community Planning Group and requested feedback and approval. Jeff Sallen called for members to vote on the approval of the report and the report was approved (8-0-0).
  - Eugene Ovruchesky with the City of San Diego presented an angle parking plan on Dagget Street between Convoy Street and Mercury Road. Proposed diagonal parking could provide more parking and not affect traffic on that street. A motion to approve the proposal to change the existing parallel parking to diagonal parking was given and the proposal was approved (7-0-1).
