The proposal will implement the first of identified "paseos" as described in the SYHV Specific Plan. This initial project will include *San Ysidro Impact Fee Study* Mobility Project M-21 "*Cypress – Trolley Rail Right-of-Way to West San Ysidro Boulevard Feasibility Study*." In conjunction with the Paseo La Paz Apartments construction, the project includes the creation of the semi-public walkway at the property lines of the apartments along Cypress Drive and West Seaward Avenue. An internal circulation system within the apartment boundary will connect to the external paseo. Apartments are at 160 W. Seaward Ave and 238-263 Cypress Drive in the RM-2-5 zone. See attachments.

b. LISC Business Improvement Grants. (Karina Velazquez, LISC). Local Initiatives Support Corporation (a not-for-profit) was recently awarded \$2M CDBG funds by the City of San Diego to run a Business Improvement Grants (BIG) program. BIG supports small businesses with the financial and

technical assistance they need to fill storefronts, expand operations, create jobs, and advance economic opportunity in San Diego's priority neighborhoods, like San Ysidro. Grants between \$5,000 and \$35,000 are available for tenant and business improvements, including new signage, window replacement, interior and exterior décor, painting, furniture, equipment, landscaping, point-of-sales systems, and more. Contact LISC at 619.541.8016.

c. Traffic Congestion at San Ysidro Land Port of Entry (PED EAST). (Miguel Aguirre, Property Owner). Stakeholders analyzed proposed solutions for mitigating growing traffic congestion. Ideas include: Traffic Monitor at peak periods to keep cross-border commuter and weekend tourist traffic flowing in order to better manage private vehicle Passenger Pick-Up Drop-Off (PPUDO) activity. Proposals include a "PASSENGER DROP OFF ONLY" at Cul-de-Sac behind McDonald's next to GSA's new southbound pedestrian plaza due for completion in September 2019. PROPOSAL FOR IMPLEMENTING PASEOS

Casa Familiar, a community development non-profit in San Ysidro, would like to implement the first "paseo" in the San Ysidro Historic Village Specific Plan area. This proposal would represent a collaboration with the City of San Diego, residents, property owners, artists, the San Ysidro Community Planning Group (SYCPG) and Casa Familiar to develop an overall vision for the Cypress Drive Paseo including design standards and elements for implementing the first paseo in San Ysidro as a pilot project. The adopted San Ysidro Community Plan (Nov. 2016) identifies the importance of creating/building lively pedestrian corridors that connect pedestrian infrastructure to important community activity centers and public transportation. This project would also include the design of the FY 2017 San Ysidro Impact Fee Study's Mobility Project number M-21 titled "Cypress-Trolley Rail Right-of-Way to West San Ysidro Boulevard Feasibility Study (Currently no funding identified, and project does not qualify for D.I.F.).

For its part, Casa Familiar (Casa) is committed to perform community outreach activities and host community workshops in FY 2019. Casa Familiar would also commit to lead implementation efforts of the Cypress Paseo as the **"Culture Corridor Project"**. This project would include space for community festivals and expansion of public arts and culture for San Ysidro curated by Casa Familiar.

This new focus ensures that the San Ysidro Community Plan implements policies and elements in the built environment that seek to formalize and enhance an existing network of pedestrian corridors, which will overall **improve neighborhood security**.

As the non-profit partner that will be providing resident services for the new "Paseo La Paz Apartments" being built by Chelsea Development, we have uncovered some serious considerations to neighborhood security that we wish to present in July for action by the SYCPG.

The Paseo La Paz safety issue is the creation of the semi-public walkway along the east property line. Both Chelsea and Casa believe this will create an unmanaged space that will reduce security and cause issues. We are preparing a presentation for the July meeting to discuss with the SYCPG.

Casa Familiar would like to request support form the SYCPG to:

- 1. Ensure all neighborhood security issues are understood and addressed.
- 2. Move the pedestrian paseo investment that Chelsea has committed to at their project site to the overall Cypress Paseo for the most community benefit. This would be coordinated by Casa and fully engage the SYCPG to develop this first pilot.

- **JUSTIFICATION:** This project is consistent with the San Ysidro Community Plan and General Plan guidelines and is needed to serve the community at full buildout.
- **SCHEDULE:** Design and construction will be scheduled once funding has been identified.
- **NOTE:** This project does not mitigate future impacts to transportation facilities and is therefore not DIF eligible, but is included for informational purposes only.

- 1. Private vehicles picking-up and dropping-off Cross-Border Passengers...CURBSIDE.

- 2. TRAFFIC CONTROLLER wearing bright fluorescent vest utilizing Control Stick-Flashlight and Whistle.
- 3. SIGNS: "NO PASSENGER PICK-UP" on street curbside allowed..."PLEASE PARK!"
- 4. TRAFFIC CALMING MEASURES: Raised painted bumps on street at driveways, temporary cones, barrels and markers, painted curbside.
- 5. As there is "No Designated" Passenger Loading/Unloading on Rail Court, ultimately, vehicles should be allowed to circulate to end of Rail Court Cul-de-Sac and quickly "DROP-OFF ONLY" as close to the pedestrian southbound crossing <u>WITHOUT BEING CITED!</u>

Conclusion

- 1. San Ysidro needs a systematic approach for PPUDO (Passenger Pick-Up Drop-Off) at PED EAST:
 - Traffic Study, or at least further analysis with stakeholders.
 - Traffic Control Safety Monitor with sign and whistle to keep traffic flowing during peak periods.
 - Signs that warn "No Curbside Passenger Pick-Up" Please Park!
 - Create "Drop-Off" Only Spot. Most logical place is CUL-DE-SAC leading to Mexico.
 - Install "FLASHING" Yellow Lights to slow down everyone, as in other Communities.
- 2. Costly tickets compound mobility issues and create irate visitors to San Ysidro. Not enough Police staff.
- 3. Restoring the Vetted Design Function of the 2003 Intermodal Transit Center (ITC) improves transportation operations by:
 - CONSOLIDATING (Confining) Modes of Travel to their respective terminals, i.e. LOCAL vs. LONG-HAUL, which also helps eliminate passenger confusion and wild-catting (illegal transit).

VACANCIES

[Excerpts from the SYCPG Bylaws of June 17, 2015]

The SYCPG should fill vacancies at the time the vacancies are declared by selection by the elected planning group members at the time the vacancies are declared, but not sooner than the next regular meeting at which a quorum is present. Vacancies shall be filled by a majority vote to elect a candidate to the vacant seat, or if more than one vacancy, then the seats are filled by plurality. Publication in a regular meeting agenda shall be sufficient notice of the vacancy.

No person shall be considered for a vacant or open seat who has previously been an elected or appointed member in the twelve (12) months immediately preceding the day the vacancy or opening was declared.

Two or more concurrent SYCPG vacancies shall be filled by a vote of all eligible members of the community by secret written ballot.

[An individual must be recorded on the SYCPG Master Membership List as determined by the Secretary, and] must be at least 18 years of age, and shall be affiliated with the community as a:

- property owner, who is an individual identified as the sole or partial owner of record, or their designee, of a real property (either developed or undeveloped), within the community planning area, or
- (2) resident, *[including a renter or tenant]* who is an individual whose primary address of residence is an address in the community planning area, or
- (3) local business person, who is a local business or not-for-profit owner, operator, or designee at a non-residential real property address in the community planning area; only one representative of a particular establishment may hold a seat on the community planning group at one time.

For the purpose of qualifying a "designee" of a not-for-profit . . . the designee must be identified by name in writing by the qualifying governing body or its chief executive.

When the SYCPG is unable to fill a vacancy within 120 days . . . and the planning group has more than twelve members, a search for a new member should continue, however either the seat may remain vacant until the next planning group election, or these bylaws may be amended to permit decreased membership to a minimum of 12 members.

To be an eligible community member an individual must be

- at least 18 years of age, and
- shall be affiliated with the community as a:
 - property owner, who is an individual identified as the sole or partial owner of record, or their designee, of a real property (either developed or undeveloped), within the community planning area, or
 - resident, who is an individual whose primary address of residence is an address in the community planning area, <u>or</u>
 - local business person, who is a local business or not-for-profit owner, operator, or designee at a non-residential real property address in the community planning area.

Only eligible community members have the right to vote at the SYCPG general election and to be a candidate for election.

An individual may become an eligible member of the community by demonstrating qualifications to the planning group Secretary or Election Committee prior to the March election or at the time of voting. Eligibility is demonstrating by filing this *Application for General Membership* and upon validation of the affiliation requirements.

For the purpose of qualifying a "designee" of a not-for-profit, in addition to this membership form, the designee must be identified by name in writing by the qualifying governing body or its senior executive.

For the purposes of qualification as a General Member, a "not-for-profit" is defined as an existing community organization, association, or institution which has its headquarters or a site office at a physical location at a non-residential real property address within the San Ysidro Community Plan area, and serves the constituents of the planning area.

Among the duties of the elected SYCPG members is the requirement to attend meetings. There are no "excused absences." The SYCPG shall find that a vacancy exists upon receipt of a resignation in writing from one of its members or upon receipt of a written report from the planning group's secretary reporting the third consecutive absence or fourth absence in the 12-month period of April through March each year, of a member(s) from the planning group's regular meetings. An individual who vacates a seat after eight consecutive years may not again be elected or appointed for a period of one year.
