- Port of San Diego Ron Powell-N/A. Larry Hofreiter presented on behalf of the Port of SD-1.) Funding for the Barrio Logan Night noise study has been approved in the amount of \$100,000. They have contracted a consultant to identify noise, to understand the regulations, etc. and to develop a report of findings. 2) South Harbor Drive Mobility Study is moving forward. They have met with Caltrans, City of San Diego-Elizabeth Ocampo Vivero, and others to analyze situation. The Study begins at the 10th Ave Terminal and ends at the National City Terminal and jettisons to 28th Street and 32nd Street. Move information will be presented at the September meeting.
- State of California, Assemblywoman Lorena Gonzalez-Fletcher -Lucero Chavez Lucas Cruz discussed the • California Latino Caucus scholarship program giving up to \$5000 to students. He also discussed AB547 that demands training on sexual harassment in the Department of Industrial Works; AB589 to prevent employers from taking personal paperwork from employees i.e. taking passports or matriculation paperwork from visa holders or undocumented workers holding them hostage until work is completed; and AB1747 a bill to protect undocumented workers through DMV and other State Agency documents.
- Report from Alpha Project: Kelly Knight-New housing for homeless opening in Mission George. The 6. shelter will also offer the opportunity for residents to do outreach to other unsheltered population to bring them into the shelter.
- 7. Report from the Barrio Logan Association: Hector Villegas—meetings are held the second Tuesday of each month in the Estrella del Mercado Apartments @ 5pm. This past week was a short meeting inclusive of a presentation by Brannan Stueve from the LISC Business Improvement Grants to support small business with financial and technical assistance. They also discussed an allocation to the LAC for La Vuelta End of Summer gathering August 24, 2019 with non BLA/MAD funds. Nora Bishay made a presentation on Park to Bay, a presentation that was done at the BLPG last year. It contained interesting concepts but still has a long way to go before there is traction. 8. Non-agenda Communication from the Public—Terry Steele, Workshop for Warriors provides 16-week training for returning veterans three times a year in welding, machining and other industrial fields. The graduates can gain credentials that will enable them to enter manufacturing careers with pay, in some cases, starting at about \$60,000. She invited everyone to the next graduation on August 16<sup>th</sup> at noon with special guest speaker SD County Supervisor Nathan Fletcher. **Ernie Salgado**—introduced himself to the BLPG and the audience. He is a life-long resident of Barrio Logan and his background includes working for the Port for 18 years, most recently with Salud Restaurant and now he is the Managing Director at Thorn Street Brewery with the goal of promoting community awareness/togetherness. They will be fulfilling their goal of including an eatery on the side lot of the Brewery. During his employment at Salud he fulfilled the goal of hiring diverse employees including ex-cons providing them with meaningful and sustainable employment easing the transition back into the community. He plans to do the same at Thorn.

**Noreen Riveroll**—attended Commander Love's departing ceremony last month. It was a special ceremony. He delivered a nice speech that was inclusive of Barrio Logan. The event was attended by his mother, brother, sister from the Dominican Republic along with his wife and children. Under his command at SD Naval Station the base was awarded a Best Service Base in the Nation.

**David Duea**—brought up a City Ordinance that is going forward to its second reading that would require gun owners to have gun locks on all arms and/or have them locked up in a sealed cabinet. He said this is a ridiculous ordinance as it would make it difficult to protect one's home from intruders etc...

## 9. Reports and discussion from the Planning Group Board

- 10. Information Item: Francisco Martinez; presentation of the Barrio Logan Planning Group Culture Survey. Panchito, BLCI Leadership Program Specialist conducted a survey by having BLPG and audience fill out a survey regarding culture and Barrio Logan. He will assess the results and begin to put the responses into a category format. He will also be reaching out into the community to include more community members in the survey. He will report at next meeting.
- 11. Information Item: Karina Velazquez, Local Initiatives Support Corporation, to discuss their program of Business Improvement Grants (BIG). Brannan Stueve presented on behalf of Karina Velasquez for LISC, a nonprofit organization that has been in place for approximately 20 years. They provide small business improvement grants that can be used to fill storefronts, expand operations, create jobs and advance economic opportunity in San Diego's priority neighborhoods. Grant size range from \$5,000-\$35,000. Eligible uses: Tenant and business improvements including new signage, window replacement, decore, painting, furniture, equipment and more. They have \$1.9 million to spend over the next two years. Ongoing discussion and action items:

- A. Community disruptive noise and light issues—SD Port District is working on this study. It was started by previous Councilmember David Alvarez and continued by Councilwoman Vivian Moreno.
- B. Handicap curb ramps needs—Brent Beltran was successful in obtaining some handicap curb ramps, however with the growing environment of hotels and business this area may need to be looked at again.
- C. Parking congestion and lack of handicap parking—This issue needs to be reassess with the growing environment.
- D. Storm water and storm drain needs—This has not been addressed.
- E. Paper street extension of 26<sup>th</sup> Street—Klaus Gohlke is working on this issue and will make a report in September at the BLPG next meeting.
- F. Traffic signals on Cesar Chavez Blvd—This issue needs to be reassessed. The City turn down the idea that there was a need for more turning signals on Cesar Chavez Blvd, however with the most recent accident on National and Cesar Chavez and the lack of consideration of pedestrians in this intersection needs to be addressed again. The BLPG will call for another study!
