NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PROJECT NAME/NUMBER: Special Event Permit – Kevin Smith Handprint Ceremony

COMMUNITY PLAN AREA: Downtown **COUNCIL DISTRICT:** 3 **LOCATION:** North drive lane, north side parking spaces and sidewalk on G Street between 5th and 6th Avenues

PROJECT DESCRIPTION: Special Event Permit for a handprint ceremony event that would include bike barricade racks, red carpeting, a portable wet cement square, and lighting that would occur on the north side of G Street between 5th and 6th Avenues on July 19, 2019. Noise associated with the event activities and set-up/dismantling would occur from 3:30 PM until 8 PM on July 19, 2019. The northern most driving lane, the northside parking spaces and the northside sidewalk closures would be associated with the event and would occur from 3:30 PM until 8 PM on G Street between 5th and 6th Avenues on July 19, 2019. On July 19, 2019, set-up would occur from 3:30 PM until 5 PM, the event would occur from 5 PM until 6 PM, and dismantling would occur from 6 PM until 8 PM.

ENVIRONMENTAL DETERMINATION: CEQA exemptions §Section 15301 (Existing Facilities); §Section 15304(e) (Minor Alterations to Land); §Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review and determined the project meets the categorical exemption criteria set forth in the CEQA State Guidelines: §Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; §Section 15304(e) (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; §Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use.

In addition, the exceptions set forth in the CEQA State Guidelines §15300.2 do not apply to this project

wherein: a) the project would not impact an environmental resource of hazardous or critical concern where designated, precisely mapped, and officially adopted pursuant to law by federal, state, or local agencies; b) no cumulative impacts of successive projects of the same type in the same place were identified; c) there is no reasonable possibility that the project would have a significant effect on the environment due to unusual circumstances; d) the project would not result in damage to scenic resources, including but not limited to, trees, historic buildings, rock outcroppings, or similar resources, within a highway officially designated as a state scenic highway; e) the project is not located on a site which is included on any list compiled pursuant to Section 65962.5 of the Government Code; and f) the project would not cause a substantial adverse change in the significance of a historical resource.
