## 8:04 pm (Action Item) Pedestrian Ramp Silt-located at Pensquitos Dr. at Del Diablo Way (#2745811), also at Penasquitos Court (#2745812), Andorra Way and Madrigal St. (#2745818)-Geoffrey Patrick RPPB District 1:

-Geoffrey Patrick: ADA ramps installed over a year ago; following the rainy season they became a collection point for silt; have established a City "Get It Done" case; case is being move to ADA dept. at the City; areas are slippery and dangerous; remains filled w/ silt even after rainy season; they wer City installed and need to be corrected; especially important being an ADA issue; will follow up on the case numbers. (additional discussion continues regarding the poor engineering and concrete work at the site and the need for follow up accordingly)

# 8:18 pm (Action Item) Emanuel Higgins with Verizon will present a project to modify the existing wireless facility at 9291 Oviedo Street, San Diego, CA 92129

-Verizon has proposed a modification to the site; Verizon has an agreement w/ the school district; facility is currently a Mono Tree and will be upgraded to a Stealth Tree; dealing with a code violation due to the initial CUP; City has changed the ordinance and Verizon now needs a new CUP; because of CUP Verizon needs the Board's approval to move forward; also, branches have fallen off; tree will be re-branched, dead landscaping will be replaced, and plants will be added to conceal the site; the project was brought before the Wireless Committee and there were no issues; site is located at Black Mountain Middle School. J. Becker inquires re: length of the CUP; E. Higgins responds w/ 10-15 years; clarifies that antennae will be 6-8 feet; site will be irrigated as part of the landscape plan.

-Re: the Power Point on the Taskforce on Community Planning Group Reform draft findings & Recommendations sent out to Board re: a Planning Board's--have highlighted key issues; notes that Planning Boards are advisory; notes specifically that when a Board takes a vote on an action item, and attaches conditions to the motion, that the City wants to know "why" we requested the conditions; that they need to have a trigger as stated in the Power Point; notes that we need to be aware of the framework that we are to work within. Also: Received a letter that spells out concerns re: the slope failure and that she wants her concerns part of the official record (see public comment). Also: Concerns coming in re: DUI drivers on Black Mtn. Road; from Paseo Monteban to Carmel Mtn. Rd. Some solutions offered were: extended bike lanes, narrowing of lanes w/ striping, and enforcement. Also: Oktoberfest: Friday, October 18 from 6-10 p.m. Also: Next update to the General Housing plan is October 5.

-Heard from D.R. Horton re: obligation to do road widening; it is part of the Torrey Highlands Financing Plan; the timeline is late 2020 through 2022; 2 lanes to the south plus a median; overall the community was in support; voted 4-0 to support; it is at Carmel Valley Rd. where Carmel Valley Rd. and Camino del Sur intersect; Fairbanks Country Villas. J. Becker notes that it is 13.5 mm in the FBA.

-In May, City Planning Commission stated that small wireless stations are a blight and requested that CPC attend a May meeting; unsure if anyone attended at the time; led to an approval of a 29 page update to the Municipal Code; found a City website that shows all proposed small call antennae stations; they are being put on street lights; they are shown on the City's website; notes that the Board has no authority to disallow.
