Discussion focus included transportation to work related down town destinations. He reported that he was impressed with the direction and organization of the evaluation process. He also discussed the specific need for the north south bus line that includes a stop of the west end of Del Mar Heights road which is the closest, public transportation to so many enterprises such as the Grand Del Mar, and the shopping centers.

# **Council District 1 - Council member Barbara Bry-Steven Hadley**

Regarding the matter of the round about at Carmel Country and Carmel Mountain road Steven Hadley noted that Carmel Valley Planning Board is working on their own study and plan for traffic control and that no changes to that intersection will be happening any time soon. Christian Tresize reported that the stop sign at the corner of Little McGonigle and Del Vino Court heading north is completely blocked by pepper trees. Steven Hadley will make a call tomorrow to have it corrected ASAP.

#### Notification Letter(s) for Beautification Committee (Draft)

Chairman Ellis commented on the draft letter from the Beautification Committee to be implemented in the notification of DMM home owners who are in violation of the community plan. Christian Tresize who is working with Kenneth Rudy on this program reported that there are approximately sixty homeowners or responsible parties that are affected by the requirements of the plan. He reported also that most parties are compliant and the number of non compliants is actually small. Christian Tresize also noted that they are developing and including a list of recommended landscape companies that are also familiar with the DMM Community Plan to include as a resource in the communication. **Chairman Ellis made the motion to send the draft letter as presented to the five to ten responsible parties as soon as possible, Secretary Rabbitt seconded, and the motion was carried unanimously.**
