Government Reports:

David Surwilo from SDPD spoke. Updated on police activities in the area to support the homeless outreach, psychiatric outreach and enforcement objectives of the department. He urged owners to follow letter of agency process to allow the police to enforce trespassing on their property.

Josh Coyne from the council district 2 office spoke. Fire station 20 improvements are fundable, and he is awaiting word from the chief on that and he will follow up. His office is working on the 5-year CIP list and Desiree's expressed by this group have been noted. Camino del Rio and Hancock left turn lane issue is being discussed and worked on with exploration. Cathy asked that someone from the traffic department come to the board prior to turn lane work commencing.

No other representatives attended.

Action Items:

Bill Zent from www.scooterban.com spoke on the corporate scooter moratorium. 1,300 signatures have been gained in favor of their group's objective of properly managing scooters versus the current free for all situation that results in risk, cost to the city taxpayers and private property value erosion.

Matt from Barbara Bry's office spoke on her desire to move forward a plan that addresses their problems with corporate scooters. Kurt moved and Mike seconded the following wording: "The MPHCPG supports official and fast consideration by the City of San Diego of and determination on corporate scooter deployment within the City of San Diego for a period of time necessary to create and implement scooter company and end user rules and regulations that provide for effective city enforcement, safety, prevention of private property value erosion and limitation of liability on the part of the city." **Board vote: 6 in favor; 1 opposed.**

Dike indicated the September meeting was adjourned so there is nothing to report. Dike has been drafted for a task force to serve on the CPC task force on Community Planning Group Reform.

The city has published an action report on homelessness calling for \$ 190 million to be spent annually in additional funds over that's currently being spent.
