NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PLANNING DEPARTMENT

PROJECT NAME/NUMBER: Special Event Permit – Padres Pedal the Cause 2019

COMMUNITY PLAN AREA: Downtown and Barrio Logan

COUNCIL DISTRICT: 3 and 8

LOCATION: Petco Park and Citywide roadways

PROJECT DESCRIPTION: Special Event Permit for that portion of a bicycle race and fundraising event that would occur within the public right-of-way within the jurisdiction of San Diego on November 16, 2019. Noise associated with the event activities and set-up/dismantling would occur from 2 AM until 5 PM on November 16, 2019. Road closures associated with the event would occur from 4 AM until 5 PM on November 16, 2019 and would include Tony Gwynn Drive between Park Boulevard/Trevor Hoffman Way and L Street, and Park Boulevard/Trevor Hoffman Way between Tony Gwynn Drive and Imperial Avenue. There would be four routes 100-mile, 88-mile, 55-mile, and 25-mile on November 16, 2019, All routes would be the same within the City of San Diego, and would begin in Petco Park, turn left onto 7th Avenue/Tony Gwynn Way, turn left onto Park Boulevard, turn right onto Imperial Avenue, turn right onto 13th Street, slight left onto National Avenue, turn left onto the bridge and leave the City's jurisdiction, reenter the City heading north on Harbor Drive, turn right onto 28th Street, turn left onto Main Street, turn right onto Cesar Chavez Parkway, turn left onto National Avenue, slight right onto 14th Street, turn left onto Imperial Avenue, turn left onto Trevor Hoffman Way, and turn right onto Tony Gwynn Drive to the finish area. All other activities associated with the Padres Pedal The Cause event would not occur in the public right-of-way. On November 16, 2019, set-up would occur from 2 AM until 4:30 AM, the event would occur from 4:30 AM until 5 PM and dismantling would occur throughout the event and would conclude by 5 PM.

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review and determined the project meets the categorical exemption criteria set forth in the CEQA State Guidelines: §Section 15301 (Existing Facilities) which allows for the

operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; §Section 15304(e) (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; §Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; §Section 15323 (Normal Operations of Facilities for Public Gatherings) which allows for the normal operations of existing facilities for public gatherings for which the facilities were designed, where there is a past history of the facility being used for the same or similar kind of purpose has been occurring for at least three years and that there is a reasonable expectation that the future occurrence of the project would not represent a change in the operation of the facility.

In addition, the exceptions set forth in the CEQA State Guidelines §15300.2 do not apply to this project wherein: a) the project would not impact an environmental resource of hazardous or critical concern where designated, precisely mapped, and officially adopted pursuant to law by federal, state, or local agencies; b) no cumulative impacts of successive projects of the same type in the same place were identified; c) there is no reasonable possibility that the project would have a significant effect on the environment due to unusual circumstances; d) the project would not result in damage to scenic resources, including but not limited to, trees, historic buildings, rock outcroppings, or similar resources, within a highway officially designated as a state scenic highway; e) the project is not located on a site which is included on any list compiled pursuant to Section 65962.5 of the Government Code; and f) the project would not cause a substantial adverse change in the significance of a historical resource.
