## RE: Additional Emergency Rental Assistance for High-need Jurisdictions

## Dear Speaker Pelosi and Majority Leader Schumer:

As you consider supplemental appropriations legislation related to our ongoing recovery from COVID19, we ask you to approve additional funding for the Emergency Rental Assistance program in order to meet the outstanding need in jurisdictions where it is unlikely that sufficient funding will be available through Treasury's process to reallocate existing funding. In our jurisdictions there are many more vulnerable people in need than the expected reallocation of funding between jurisdictions will allow. It is critical that Congress provides additional resources and ensures no family faces eviction due to rental arrears accrued due to the economic impact of the COVID-19 pandemic.

More than $\$ 27$ billion in existing ERAP funding has been spent or obligated to approximately 10 million people living in over 3.2 million renter households nationwide to keep families who have experienced hardships due to the current pandemic in their homes. Over the last 6 months, ERAP has successfully prioritized and expedited funding disbursements to approved applicants, providing necessary financial relief to tenants and landlords during the unprecedented public health crisis.

Despite this good work, additional funding for this program is needed. The Department of Treasury's first ERAP reallocation payment did not provide high-need jurisdictions with adequate funding to meet the demand we are experiencing. For example, the California Department of Housing and Community Development was awarded $\$ 50.3$ million from the first direct payment of the Treasury's national ERAP reallocation. Yet, the demand for additional emergency rental assistance in Los Angeles alone is
estimated at more than $\$ 960$ million. The State of New York is requesting $\$ 1.6$ billion for reallocation but only received $\$ 27$ million from the first reallocation ${ }^{1}$. Similarly, the state of Texas requested $\$ 3$ billion but did not receive any funding, with only $\$ 19$ million $^{2}$ in total being reallocated to several Texas cities and counties. Other jurisdictions across the country still have tremendous outstanding need. For example, the City of Boston has an outstanding need of roughly $\$ 80$ million; the City of Oakland has an outstanding need of roughly $\$ 20$ million and, on January 7 , opened a waitlist as its local program is oversubscribed that had over 1,300 households as of February 11; the City of San Diego has an outstanding need of $\$ 36$ million as of February 3 and anticipates needing $\$ 96$ million to serve tenants based on the current rate of approved applications. Therefore, we expect Treasury's first and second ERAP reallocation payments will be insufficient and not meet the scale of need in our jurisdictions.

As leaders in high-need jurisdictions, we know the need of our residents on the ground. We want to continue to lead an equitable recovery approach by supporting the most vulnerable residents in our cities who are disproportionately impacted by the pandemic. This includes low-income households, single-parent families, families with children, and communities of color. Recovery and support start with keeping a roof over the heads of these families. Cities and states cannot do this alone. That is why it is critical for Congress to provide additional funding for the Emergency Rental Assistance programs for high-need jurisdictions based on outstanding need.
