- I. CALL TO ORDER/WELCOME: 12:03 p.m.
- II. PURPOSE OF THE COMMUNITY REVIEW BOARD ON POLICE PRACTICES: Chair Joe Craver waived the reading of the purpose of the Community Review Board on Police Practices because no one from the public was present.
- **III.** PURPOSE OF THE EXECUTIVE COMMITTEE: Chair Joe Craver waived the reading of the purpose of the Executive Committee because no one from the public was present.
- IV. APPROVAL OF EXECUTIVE COMMITTEE MEETING MINUTES FROM AUGUST 21, 2019: The Committee members agreed to add member Nancy

Vaughn to the section of the minutes that mentions attendees of the NACOLE Conference. Member Maria Nieto–Senour moved for the Committee to approve the meeting minutes of August 21, 2019. Member Ramon Montano seconded the motion. The motion passed with a vote of 5-0-0.

- V. SAN DIEGO POLICE DEPARTMENT REPORT
 - A. Case load for CRB (Category I, Discipline Reports, Officer-Involved Shooting Cases, In-Custody Death Cases) – SDPD Captain Morris reported that there is a 300-page case and 2 in-custody death cases going to the CRB soon.
 - B. Shared Database Update Internal Affairs will encrypt and email the database information to the CRB's Executive Director each Friday until the technical issues are cleared up.
 - C. IA Logistics Captain Morris reported that Executive Assistant Chief Jarvis retired on November 1st. Chief Nisleit appointed Assistant Chief Al Guaderrama as the new Executive Assistant Chief. Detective Gary Gonzales is being moved over to Neighborhood Policing. Lt. Mark Bennett retired. His position has not been filled yet.
 - D. Joint Complaint Form (Status of Spanish Version) The joint complaint form is out in the field and in the command stations. There is a Spanish version that was given to CRB members Ramon Montano and Maria Nieto-Senour for feedback. Mr. Montano stated that he reviewed the form and saw a few minor corrections such as "badge", "board", and "committee". Captain Morris said that the goal is for people to understand what the form says.
- VI. AGENDA PLAN FOR NOVEMBER 26, 2019 OPEN SESSION MEETING (Chair Joe Craver)
 - A. Educational Topic 2nd Vice Chair Taura Gentry reported that Allie Rice from the Deaf and Community Services of San Diego will talk about how they assist officers with encounters with the hearing impaired.

- B. Unfinished Business on IA Tables 1st Vice Chair Brandon Hilpert agreed to report to the Board that paper copies were provided to the member so the issue has been addressed.
- C. Continuing Education Committee Committee Chair Taura Gentry agreed to provide an update on this item in 5 minutes.

- E. Rules Committee Committee Chair Doug Case agreed to provide an update on this item in 2 minutes or less.

- F. CRB Handbook Committee Committee Chair Doug Case reported that the handbook is complete. The next step is reorganizing what goes on the website. We will hand out the binders at the next meeting. Committee Chair Case agreed to give his report in 2 minutes.
- G. Policy Committee Committee Chair Brandon Hilpert requested 5 minutes or less for his report. Since the Committee did not meet this month, he will give a quick summary of outstanding items.

H. Recruitment and Training Committee – Committee Chair Nieto– Senour will provide an update on the Phase I training.
