REVISED NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PLANNING DEPARTMENT

PROJECT NAME/NUMBER: Special Event Permit - San Diego Resolution Run

COMMUNITY PLAN AREA: Mission Bay Park

COUNCIL DISTRICT: 2

LOCATION: Fiesta Island and Tecolote Shores North Park

PROJECT DESCRIPTION: Special Event Permit for a 5K, 10/K, and half marathon event that would include the routes, vendors, food trucks, a stage, portable restrooms, and the temporary use of tables, chairs, and canopies that would occur on January 13, 2020. Noise associated with the event activities and set-up/dismantling would occur from 9 AM on January 10, 2020, until 12 PM on January 11, 2020. All routes would start at Tecolote Shores North Park and complete a clockwise loop on Fiesta Island, with the 5K returning to the starting area. The 10K would continue north on the pathways to a turnaround point in De Anza Cove, where participants would u-turn and head back to the finish/start area. The half marathon would exit Fiesta Island, turn right on pathway, u-turn near the South Shores Boat Ramp, and follow the 10K route to the finish line. A sound system would be used for announcements/entertainment and sound amplification would occur from 6 AM until 11 AM. Road closures associated with the event would occur and would include Fiesta Island Road from 6 AM through 9 AM; De Anza Road south of N. Mission Bay Drive, N. Mission Bay Drive between the bike path and the Mission Bay I-5 off-ramp intersection, and East Mission Bay Drive between Sea World Drive and the Hilton Hotel from 5 AM until 11 AM. On January 10, 2020, set-up would occur from 9 AM until 5 PM. On January 11, 2020, set-up would occur from 5 AM until 6 AM, the event would occur from 6 AM until 11 AM, and dismantling would occur from 11 AM to 12 PM. On January 13, 2020, portable restrooms would be picked up by 8 AM.

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review and determined the project meets the categorical exemption criteria set forth in the CEQA State Guidelines: §Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or

private structures or facilities involving negligible or no expansion of use; §Section 15304(e) (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; §Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; §Section 15323 (Normal Operations of Facilities for Public Gatherings) which allows for the normal operations of existing facilities for public gatherings for which the facilities were designed, where there is a past history of the facility being used for the same or similar kind of purpose has been occurring for at least three years and that there is a reasonable expectation that the future occurrence of the project would not represent a change in the operation of the facility.

In addition, the exceptions set forth in the CEQA State Guidelines §15300.2 do not apply to this project wherein: a) the project would not impact an environmental resource of hazardous or critical concern where designated, precisely mapped, and officially adopted pursuant to law by federal, state, or local agencies; b) no cumulative impacts of successive projects of the same type in the same place were identified; c) there is no reasonable possibility that the project would have a significant effect on the environment due to unusual circumstances; d) the project would not result in damage to scenic resources, including but not limited to, trees, historic buildings, rock outcroppings, or similar resources, within a highway officially designated as a state scenic highway; e) the project is not located on a site which is included on any list compiled pursuant to Section 65962.5 of the Government Code; and f) the project would not cause a substantial adverse change in the significance of a historical resource.
