7:16 p.m. Reports

- San Diego Police Officer Vicki Coore had no updates on crime statistics or upcoming events. Q: Chief Nisleit changed crime statistics reporting to be 30 days behind, can the community change this? A: Unknown, but how we previously reported is on crimemapping.com, which does get information from the city, though it is unknown if it comes directly from SDPD. Q: Who is the CHUCKY RIP that has been tagged a lot lately? Is it a concern for further violence in the community? A: Unknown, but memorials do not usually result in retaliations.

- xi. Community questions:
  - Q: Our community plan lists sources of funding no longer available. Is the council involved in revitalizing and identifying available funding?

A: District and mayor's office have to coordinate with the city's financing team, please talk to both.

Q: Has the Planning Commission loosened distances of separation for dispensaries?

A: Unknown.

Q: There's a projected deficit of \$95 million; how will that affect CPGs? A: Will ask our Chief of Staff, but answers may be available during State of the City.

- c. Representative for Assemblymember Dr. Shirley Weber, Denise Green:
  - i. Session started two weeks ago
  - ii. Please fill out the census.
- iii. This year you can make \$19-23 per hour to work for the census.

- 3. G. Preuss summarized recent CPC actions.
  - a. CPC did not meet. Attended the Land Development Monitoring Committee.
  - b. LDMC is working on the twelfth update to the municipal code and are in violation of the city charter and are now an ad hoc committee.

1. SPHCPG Administration- Elections will be held during the March 10, 2020 Community Planning meeting. Eligible community members must be homeowners, renters, or business owners within the planning group area and have attended at least three meetings.

7:43 p.m. Action items

1. T-Mobile permit extension request for 5901 Rancho Hills Drive, PROJECT NO. 440346-*Vince Voss*. Permit was initially approved for three years in November 2016. Involves an aesthetic change to blend in better with the landscape. This location is not on a property with a home, is on a hill for optimal coverage by the 805 and 54, and there will be a significant gap in coverage if removed.

Q: Improvement in coverage? A: No, mostly aesthetic, but we hope to upgrade with 5G in the next few years.

Q: How should people adversely affected by proximity to these towers deal with their impact? A: It's not a high traffic area, but the addition of the dome will cut down on interference. An RF energy test has been conducted and the city has deemed it safe.

 Woodman Court Landscape Project- *David Weiland* Project on Skyline and Woodman. Project was approved 3.5 years ago. Ready to grade, final map is now available for recording and would like approval. Project is otherwise on track as approved.

Q: Parliamentarian notes agenda item is not specific to request for map approval and should be moved to next month's agenda. A: Pushback of approval to February agenda is not likely to affect project's timeline.

Motion to remove agenda item from agenda 1- W. Glover, 2nd-G. Preuss; approved 7-2. Motion to add agenda item as Woodman Court Map Extension to February agenda 1-S. Jenkins, 2nd-G. Preuss; approved 9-0.

3. Letter for Support for Better Energy Franchise Agreements for Use of Our Public Right of Way- *Climate Action Campaign Representative* Proposed letter was posted to SPHCPG social media pages concerning end of SDG&E franchise agreement with the city of San Diego. CAC proposes new contract with whichever company or companies to include: Facilitate equitable access to local solar power for all City residents and businesses; Include specific provisions to meet or exceed current worker protections, standards and wages, and the right to unionize; Limit the term to no more than five years to allow for regular performance evaluation and updates to incorporate evolving technology opportunities; Require shareholders, not customers, to pay for the use of the public right of way; Mandate a "cooperation requirement" for City prior review and approval of franchisee's legislative or regulatory proposals that could impact the City's energy system; and Mandate a daily penalty fee, paid by shareholders, if franchisee violates agreement terms.

Q: How does the right-of-way work now? A: Current contract allows SDG&E access to public right-of-way for franchise fee, which SDG&E then passes on to customers.

Q: Has the court ruled in favor of SDG&E over refusal to pay for relocation of equipment for the Pure Water project, as contract requires? A: The city hasn't sued, yet, and hopes to recover the cost from SDG&E at a later date in order to move ahead with the Pure Water project.

Q: If you have solar and a Tesla wall, you're off the grid? A: Yes, and we'd like to protect your ability to do that.

Q: Where will electricity come from if this goes through community choice? A: This letter concerns contract negotiations for whichever company/ies win the next contract with the city, including community choice.

Q: The distribution system in place is owned by SDG&E. Don't they have a monopoly on the equipment? A: Yes, but another company could buy out SDG&E's equipment.

Q: When does the current, 50 year contract expire? A: December 2021. We need to have input during negotiations, which will occur before the current contract expires in order to have a new contract in place before it does. A new contract could be signed as early as this year.

Q: This addresses who pays franchise fees? Don't fee increases go through Sacramento for approval? A: Yes, and yes, but the approval process in Sacramento is basically a rubber stamp to pass fees on to customers.

Q: Where can we see the current contract? A: Yes. https://www.sandiego.gov/undergrounding/documents/franchise

Q: Are there any good parts to the current contract? A: Yes, but it has no teeth. The Pure Water project issues are an example.

Motion to approve Letter for Support for Better Energy Franchise Agreements for Use of Our Public Right of Way 1- W. English, 2nd- S. Jenkins; approved 8-1. Chair notes this is on behalf of the Skyline Paradise Hills Planning Committee, not a personal endorsement, which committee members can choose to give or not separately.
