## REVISED NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

**PROJECT NAME/NUMBER:** Special Event Permit – Quartyard 5-Year Anniversary

**COMMUNITY PLAN AREA:** Downtown

**COUNCIL DISTRICT: 3** 

LOCATION: Market Street between 13th and 14th Streets, parking spaces on 13th Street adjacent to

venue

**PROJECT DESCRIPTION:** Special Event Permit for that portion of the 21-year old and up anniversary event that would occur within the City of San Diego's jurisdiction that would include the temporary use of food stations, adult beverages, lighting, two stages, entertainment, canopies, tables, and chairs Market Street between 13<sup>th</sup> and 14<sup>th</sup> Streets on April 4, 2020. Noise associated with the event activities and set-up/dismantling would occur from 11–9 AM until 11:59 PM on April 4, 2020. A road closure would be associated with the event and would include Market Street between 13<sup>th</sup> and 14<sup>th</sup> Streets from 11–9 AM until 11:59 PM. The parking spaces along the east side of 13<sup>th</sup> Street south of Market and adjacent to the site would be unavailable for public use from 11–9 AM until 11:59 PM. There would be stages for entertainment and amplified sound would occur from 2 PM until 10 PM. On April 4, 2020, set-up would occur from 11–9 AM until 4-3 PM, and the event would occur from 4-3 PM until 10–9 PM, and dismantling would occur from 10–9 PM until 11:59 PM.

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review and determined the project meets the categorical exemption criteria set forth in the CEQA State Guidelines: §Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; §Section 15304(e) (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; §Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; §Section 15323 (Normal Operations of Facilities for Public Gatherings)

which allows for the normal operations of existing facilities for public gatherings for which the facilities were designed, where there is a past history of the facility being used for the same or similar kind of purpose has been occurring for at least three years and that there is a reasonable expectation that the future occurrence of the project would not represent a change in the operation of the facility.

In addition, the exceptions set forth in the CEQA State Guidelines §15300.2 do not apply to this project wherein: a) the project would not impact an environmental resource of hazardous or critical concern where designated, precisely mapped, and officially adopted pursuant to law by federal, state, or local agencies; b) no cumulative impacts of successive projects of the same type in the same place were identified; c) there is no reasonable possibility that the project would have a significant effect on the environment due to unusual circumstances; d) the project would not result in damage to scenic resources, including but not limited to, trees, historic buildings, rock outcroppings, or similar resources, within a highway officially designated as a state scenic highway; e) the project is not located on a site which is included on any list compiled pursuant to Section 65962.5 of the Government Code; and f) the project would not cause a substantial adverse change in the significance of a historical resource.
