# **NOTICE OF RIGHT TO APPEAL**

## **ENVIRONMENTAL DETERMINATION**

### **PLANNING DEPARTMENT**

**PROJECT NAME/NUMBER:** Special Event Permit - Lululemon San Diego 10K

**COMMUNITY PLAN AREA:** Peninsula and Downtown

**COUNCIL DISTRICT:** 2 and 3

**LOCATION:** Shelter Island, city roadways, and Waterfront Park

**PROJECT DESCRIPTION:** Special Event Permit for that portion of a 10K race event and festival that would occur on November 1, 2020. Noise associated with the event activities and set-up/dismantling would occur from 8 AM on October 31, 2020 until 2 PM on November 1, 2020. The finish/festival area would occur at Waterfront Park and would be within the County of San Diego jurisdiction. The 10K route would begin at the traffic circle on Shelter Island, head north on Shelter Island Road, turn right onto Scott Street, turn right onto N. Harbor Drive, turn right onto Harbor Island Drive to turnaround, head back on Harbor Island Drive to turning circle at east end, head back on Harbor Island Drive to Liberator Way, turn right onto N. Harbor Drive, and finish at Waterfront Park. Road closures would be associated with the event and would include NB Shelter Island Drive between the traffic circle and Scott Street, NB Scott Street between Shelter Island Drive and N. Harbor Drive, EB N. Harbor Drive between Scott Street Harbor Island Drive, EB lane of Harbor Island Drive, NB lane of Harbor Island Drive, single lane of Liberator Way, single EB/SB lane of N. Harbor Drive between Liberator Way and Grape Street, and all of N. Harbor Drive between Grape and Ash Streets from 6:30 AM until 9:30 AM. On October 31, 2020, set-up would occur from 8 AM until 5 PM. On November 1, 2020, set-up would occur from 3 AM until 6:30 AM, the race would occur from 6:30 AM until 9:30 AM, and dismantling would occur from 9:30 AM until 11 AM.

**ENVIRONMENTAL DETERMINATION:** CEQA exemptions §Section 15301 (Existing Facilities); §Section 15304(e) (Minor Alterations to Land); §Section 15311 (Accessory Structures); §Section 15323 (Normal Operations of Facilities for Public Gatherings).

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego Mayor-Appointed Designee

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review and determined the project meets the categorical exemption criteria set forth in the CEQA State Guidelines: §Section 15301 (Existing Facilities) which allows for the

operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; §Section 15304(e) (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; §Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; §Section 15323 (Normal Operations of Facilities for Public Gatherings) which allows for the normal operations of existing facilities for public gatherings for which the facilities were designed, where there is a past history of the facility being used for the same or similar kind of purpose has been occurring for at least three years and that there is a reasonable expectation that the future occurrence of the project would not represent a change in the operation of the facility.

In addition, the exceptions set forth in the CEQA State Guidelines §15300.2 do not apply to this project wherein: a) the project would not impact an environmental resource of hazardous or critical concern where designated, precisely mapped, and officially adopted pursuant to law by federal, state, or local agencies; b) no cumulative impacts of successive projects of the same type in the same place were identified; c) there is no reasonable possibility that the project would have a significant effect on the environment due to unusual circumstances; d) the project would not result in damage to scenic resources, including but not limited to, trees, historic buildings, rock outcroppings, or similar resources, within a highway officially designated as a state scenic highway; e) the project is not located on a site which is included on any list compiled pursuant to Section 65962.5 of the Government Code; and f) the project would not cause a substantial adverse change in the significance of a historical resource.
