- Community Givebacks The volunteering and charity efforts we IV. participate in inside and outside our normal work hours.



**East Village Residents Group (2)** –Meets every other month to discuss criminal activity that is occurring around residential buildings in the East Village area.







Rotary Club presentation – Community Relations Officers was a guest speaker at the Rotary Club in Ranch Bernardo.



The monthly meeting discusses and plans both police and code enforcement to target criminal activities and code violations at locations identified as chronic narcotic, disturbances, and repeat calls for service addresses to improve our community's safety and quality of life. Once we have identified the targeted locations Sgt's, detective's and officers assigned to the locations are invited to the meeting to gain information, updates and provide updates and summaries of what has been occurring. This is a Western Division team project and another example of how we are able to bring different resources and units together to target criminal behavior and bring a final resolution to problems.

**Linda Vista Town Council Meeting (2)** -Linda Vista Town Council's primary objective of improving the quality of life in our community making this a perfect meeting to attend to strengthen our partnership with the very diverse community of Linda Vista. Regularly attended by the division's CRO's. They took questions regarding crime trends and police enforcement within the Linda Vista community.

#### **Community Outreach**

**Community Conference on Surveillance Cameras at the Ocean Beach Life Guard Tower** -Councilmember Lorie Zapf, San Diego Police Department, City Staff and Ocean Beach Residents were present at the Ocean Beach Life Guard Tower to announce the installment of surveillance cameras in Ocean Beach. The request for the cameras to be installed was made by the San Diego Police Department and supported by the Ocean Beach Town Council to deter crime.

**Grace Lutheran Church Preschool Staff Day Training** -CRO's Surwilo and Pinon conducted safety training for the preschool staff regarding the schools safety concerns when dealing with homeless, child drop off safety and intoxicated neighbors trespassing. The staff was educated on how and when to call the police, lockdowns and the importance of Letters of Agencies.

**Community Discussion on local gangs** –CRO Pinon met with several Linda Vista professionals at Bayside 2202 Comstock St. and discussed concerns with local gangs. The group came together to discuss service outreach and education to families affected by the gang culture.

**Problem Oriented Policing Project** -CRO Pinon met with five business owners at 3400 Sports Arena Blvd who were concerned with the uptick in illegal activity and homeless encampments on their block. The discussion focused upon the negative effects of homeless outside their businesses and their own personal experiences in observing illegal activity on a daily basis. The Homeless Outreach Team, Quality of Life Team and City Code Enforcement worked together to provide homeless housing opportunities and education. The encampments along Sports Arena Blvd were cleaned up.

**Montgomery Middle School Safe School Zones Program (2)** – CRO Pinon was invited by staff of Rady Children's Hospital and Montgomery Middle School to support safe school zones and safety volunteer program.

**Realtor Safety Meeting Fashion Valley/Friars Rd** –CRO Pinon and CRO Surwilo conducted a safety presentation to a group of 50 Realtor Professionals. We provided safety strategies for meeting people in public and hosted an open house.

**San Diego Juvenile Interagency Group (2)** –A monthly meeting aimed at dispersing up to date information related to juveniles and the law across San Diego law enforcement agencies.

National Night Out Colina Park Committee (3) –STAR-PAL served on the committee for the National Night Out event at Colina Del Sol Park. National Night Out events across the nation provide an annual opportunity for community building and promoting neighborhood safety, strengthening community-police relations and trust.

**Shop with a Cop Committee (3)** –A monthly meeting with agency representatives for the planning of the 2016 Shop with a Cop event. STAR/PAL is responsible for coordinating the 300+ youth participants by working with school counselors and officers from throughout the County for referrals.

### **Community Involvement**

**Life Skills Program (3)** -A voluntary program to help youth currently being supervised by the Juvenile Gang Suppression Unit to establish skills and assist them in their transition to adulthood. The program offers an 8-week curriculum designed to educate and prepare the youth to become self-sufficient by providing them with tools to enter the work force, manage their money and finances, assist in obtaining a driver's license and/or identification card, offer tattoo removal, discuss military/college/trade school options, probation record sealing, and educate them on healthy lifestyles. The program consists of class lectures, field trips, and homework.

**Mentoring Youth for Tomorrow (32)** –A daily afterschool event (Mon–Thur). Mentoring Youth for Tomorrow (MYT) is a program that enables inner–city youth the opportunity to take part in a mentoring program with volunteers, law enforcement officers, and students from SDSU and UCSD. It includes homework assistance, athletic activities, educational field trips, and recreational opportunities, all with positive mentorship that includes law enforcement officers working directly with youth. This program is held on–site at the STAR/PAL Center to serve youth in Mid–City Division.

**Making Changes (3)** -The Making Changes program is a year-round, 40-session program that brings youth, law enforcement, and volunteer mentors together for a civic engagement based curriculum, designed to educate high school teens about the importance of making positive life decisions and how these choices can impact their lives, their communities, the nation, and even the world. This program hopes to promote awareness about the importance of one's actions and the potential these actions have to make positive change. This program is held on-site at the STAR/PAL Center to serve youth in Mid-City Division.

**Teen LEAP (Leadership, Empowerment, Awareness Program) (11)** -Teen LEAP is a 30-session curriculum led by STAR/PAL officers that encourages youth participants to develop as effective leaders within their schools and communities. By engaging teens in new experiences including volunteering at retirement homes, community revitalization projects, and various outdoor excursions, this program strives to promote awareness about community issues as well as provide young adults with the tools to address them through leadership and civic engagement. This program is currently taught on campus at Gompers Preparatory Academy in Southeastern Division and Crawford High School located in the Colina Del Sol neighborhood in Mid City Division.

**Get Elevated Boot Camp (8)** –High school age youth who participate in this 8– session program learn from representatives of the San Diego Police Department, the Army National Guard, Toastmasters International, National Conflict Resolution Center, and other collaborative partners about teambuilding, social responsibility, public speaking, goal setting, financial literacy, community service, and civic engagement.

**Junior Chargers Training Camps (7)** –STAR/PAL officers, with the support of the San Diego Chargers and NFL Play 60, run a series of Junior Chargers Training Camps each year throughout the County of San Diego. Each camp gives 100 youth participants (ages 8–14) from various communities the opportunity to run football drills with public safety volunteers. At the camps, youth not only learn about the basics of football but also hear from Chargers players and law enforcement officers about the importance of a healthy lifestyle through exercise and following academic goals. In addition, this program promotes positive interaction between youth and local law enforcement officers in a team sport environment.

**Padres Baseball Clinics (4)** –STAR-PAL officers, in partnership with the San Diego Padres, offer youth baseball camps at several local parks and recreation centers and school sites in underserved communities throughout greater San Diego during the spring and summer months. These two-day camps expose hundreds of boys and girls to the game of baseball while emphasizing the importance of academics, healthy choices, and fitness. In addition, this program promotes positive interaction between youth and local law enforcement officers in a team sport environment.

San Diego Chargers Games (California Police Youth Charities) (2) – In partnership with California Police Youth Charities, STAR–PAL officers take 8 underserved youth to experience a San Diego Chargers game. Event includes a BBQ for the youth in the tailgate area at Qualcomm Stadium.

**Outdoor Enrichment Activities (8)** –STAR–PAL officers took underserved youth on outdoor excursions during the summer, which include activities such as sailing, kayaking, hiking, and stand up paddle boarding.

**Annual Surf Clinic** -Over 60 underserved youth "hit the surf" with the help of law enforcement and public safety mentors at our annual Surf Clinic. Participants, ages 9–16, from various communities in San Diego learned about ocean safety and the fundamentals of surfing while engaging with STAR-PAL officers, community volunteers, and other law enforcement role models in a positive and active environment.

MCRD Girl Power – STAR/PAL officers and female youth from military families participated in a one day leadership camp focused on empowerment and selfesteem. Law Enforcement Officers and MCRD staff members put on the one day camp at MCRD where they taught classes, led teamwork projects, and facilitated deep group discussions on real life issues and how to work through them.

**Horse of the Sun Ranch (4)** –8 youth attended Horse of the Sun Ranch Cowboy Camp with STAR-PAL officers and staff. At the camp, participants learned about horses, how to ride, how to herd cattle, went on hikes, practiced archery, and did arts and crafts.

**National Night Out (2)** –National Night Out is an annual community–building campaign that promotes police–community partnerships and neighborhood camaraderie to make our neighborhoods safer, better places to live. Together, we are making that happen. National Night Out enhances the relationship between neighbors and law enforcement while bringing back a true sense of community and provides a great opportunity to bring police and neighbors together under positive circumstances. Officers attended events throughout the night.

#### **Community Outreach**

**Presentations at local schools and CBOs (2)** –Presentations by STAR/PAL Officers for at-risk youth covering issues such as making positive life choices, bullying, bike safety, improving self-esteem, and information about the law as it relates to juveniles.

**Basketball Camp at MCRD** – STAR/PAL partnered with the Young Marines Community Outreach Program and put on a basketball camp for youth of military families around the county. The clinic was a mix of skills building, team work, and information about basketball all while working with law enforcement and military members to bring them closer as a community. After the camp Law Enforcement Officers and Marines cooked lunch for the youth and ate with them to continue the partnership.

**Peace Gathering event at Qualcomm** – Youth from the Making Changes program along with STAR/PAL staff members attended the gathering. The youth attended and were able to be a voice for the community and to be a voice as a partner of law enforcement.



Diamond Street Festival -Youth from our Making Changes program and STAR/PAL staff hosted a booth and participated in the Second Annual Diamond Street Festival, a day of community celebration that takes place in the heart of San Diego's Diamond Neighborhoods on Saturday, July 16, 2016. This unique street festival celebrates the rich history, diverse cultures, and captivating energy of the people of Southeastern San Diego.

#### **Community Giveback**

Couture for a Cause Beneficiary Event -STAR-PAL was once again selected as a beneficiary charity (along with Voices for Children) of this fashion show event hosted by the legal community at the San Diego Hall of Champions. The event is anticipated to raise more than \$10,000 for STAR/PAL. One STAR/PAL youth, Lizbeth, shared her story and participated as a model in the charity fashion show, with other members of the STAR/PAL team in attendance.

**Shop with a Cop BBQ Fundraiser** – STAR/PAL participated in the set up and break down of a BBQ at La Mesa PD to benefit the 2016 Shop with a Cop event.

**Crime Stoppers** – San Diego County Crime Stoppers Inc. provides three ways that the public can submit tips anonymously to report on felony crimes; they can call a tip line (888) 580–8477, submit a tip via the website or send a text tip from their phone. Crime Stoppers combats the three major problems law enforcement faces in gathering information; fear of reprisal, apathy, and a reluctance to get involved. San Diego County Crime Stoppers Inc. overcomes these challenges by providing citizens a safe way to anonymously report crime and rewards citizens for tips leading to a felony arrest.

### **Community Partnerships**

**Violent Loss Support Group Meetings (3)** – A monthly meeting to provide support and resources to families of violent crime victims.

### **Community Involvement**

**School Fairs** –An "as requested" event to attend school fairs throughout the county in an effort to promote the Crime Stoppers program.

**Candlelight Vigils** – An "as requested" event to show support for families of violent crime victims and to provide resources via the Crime Stoppers Program.

**Crime Stoppers Enough is Enough Annual Luncheon** – This event honors local law enforcement, business leaders, and students for their contributions in making their communities safer. This event also helps raise money to pay for Crime Stoppers' programs and the felony reward fund.

### **Community Outreach**

**Crime Stoppers Information Meetings** –An "as requested" meeting to define the role of Crime Stoppers in crime prevention strategies.

Students Speaking Out Program - A quarterly meeting for schools throughout the County on the benefits and uses of the Crime Stoppers program.

Crime Free Multi-Housing Program - In 2010, the San Diego Police Department entered into a collaborative partnership with the Institute for Public Strategies and the managers/owners of San Diego multi-housing communities dedicated to crime prevention and the Crime Free Multi-Housing Program. In 2012, Say San Diego joined the team and to date, 232 properties have been certified. The program illustrates the success of communities, non-profit organizations, and law enforcement coming together in the fight against crime.

#### **Community Involvement**

Crime Free Multi-Housing Certification (6) – Six multi-housing communities completed an 8 hour education class, passed the CPTED inspection, and participated in a resident engagement meeting receiving a Crime Free Multi-Housing certification certificate.

### **Community Outreach**

Crime Prevention Through Environmental Design Inspections CPTED (13) -Rental property inspections to assess physical security and general appearance of property to deter criminal activity.

**Safety Meetings (7)** – Meetings held with residents to discuss the Crime Free Multi-Housing Program, CPTED, reporting guidelines, and general safety information.

Social Media – Social media is designed to enhance our communication outreach with the community. The San Diego Police Department currently uses three primary forms of social media that include Facebook, Twitter and Nextdoor.com. These platforms allow the Department to provide meaningful and timely information to our public on a variety of topics including community events, notification of crime issues, news stories and major incidents occurring in the City.

### **Community Involvement**

**Volunteer Services** – No police department is large enough to keep a community safe on its own. Effective crime prevention requires the active support of citizens and a partnership between police and the community. Community policing is an important foundation of the San Diego Police Department. What makes San Diego's approach to community policing unique is the extent to which the police department has made volunteers an integral component of its program.

The San Diego Police Department is viewed as a leading force in law enforcement innovations occurring across North America. The Department's adult and youth volunteer workforce has approximately 700 members. These volunteers play a vital role in the department's vision to engage the community in a problem solving partnership that will reduce crime and positively affect the quality of life in all communities.

The San Diego Police Department has used volunteers for a wide variety of job assignments for many years. Programs throughout the Department are considered models in volunteerism in the public sector. Volunteers are essential to Department operations. They help provide a level of customer service that could not be achieved by the Department's staff alone. Volunteers represent all segments of society. The variety of functions performed by this police department affords opportunities for people with varied interests and skills. The San Diego Police Department's Volunteers in Policing (VIP) program offers a unique opportunity for citizen volunteers to become actively involved in providing efficient, effective, and responsive service to our community.

The use of volunteers includes Crisis Interventionists, Retired Senior Volunteer Patrols, Volunteers in Policing, Reserve Officers, Police Cadets, and various support staff positions that enhance the organization's effectiveness. This is a result of two decades of change in policing philosophy that has heralded San Diego as a pioneer in many areas of law enforcement.

The San Diego Police Department has a significant resource available in the San Diego community: individuals who are ready, willing, and able to serve as volunteers. In a time of limited financial resources and increasing demands for services, it is important that volunteer opportunities continue to be identified and this resource increasingly utilized.

Currently, The San Diego Police Department has 93 active Crisis Interventionists, 321 RSVPs, 29 Reserve Officers, 91 VIPs, and 50 Cadets. Our RSVPs contributed 28,493 hours this quarter. Crisis Interventionists responded to 139 callouts assisting 846 people, worked 4,001 hours, and were on call and prepared to respond for an additional 2,755 hours; our Reserve Officers worked a total of 1830.5 hours 708 of those hours went directly to Patrol; our VIPs contributed 4,487 hours.

Ride Along Program (181) - The Ride Along Program is a powerful community involvement tool that enables an officer to showcase to citizens who live, work, or go to school in the officer's area of responsibility the daily duties of a police officer. It enables citizens to get a first-hand look at policing and to better understand the role of the police. It increases the opportunity for more effective problem solving, and it enhances mutual understanding and cooperation and leads to an improved police/community relationship.

### **Community Outreach**

Community Recruiting Events (66) – From July 1st, 2016 through September 30<sup>th,</sup> 2016 The Recruiting Unit gave presentations on career opportunities as a police officer and dispatcher at <u>66</u> community events throughout the City and County.

### **Community Partnerships**

Alternatives to Detention (2) – ATD is designed for placement of juvenile misdemeanor offenders into an alternative location other than Juvenile Hall (i.e. cool bed). Representatives are available to respond to the officer's location to conduct an assessment of the juvenile for placement. After receiving parental consent, the juvenile will be placed in an approved location. Juvenile Administration and JST Officers attend these meetings to discuss juvenile issues, placements and laws.

**Joint Interagency Meeting** –Monthly meetings presented by the Juvenile District Attorney's office. Multiple county law enforcement agencies attend this meeting in order to receive updates on laws regarding juveniles, juvenile adjudication procedures and training on various programs.

**CARE Community Center** –On July 11, 2016, Juvenile Administration attended the grand opening of the CARE Community Center in Southeastern Division. The CARE Center is a product of community collaboration with the San Diego County District Attorney's office aimed at actively linking individuals from the community with community-based prevention and intervention services with the goal of building strong community relationships and reducing crime.

Juvenile Justice Coordinating Council – In an effort to ensure coordination and collaboration among the various local agencies serving at-risk youth and young offenders, the JJCPA legislation requires the county Juvenile Justice Coordinating Council (JJCC) to develop and modify the plan. The JJCC is chaired by the county's chief probation officer and its members include representatives of law enforcement and criminal justice agencies, the board of supervisors, social services, education, mental health, and community-based organizations. The JJCC meets periodically to review program progress and evaluation data.



Interagency Safety Committee – The Interagency Safety Committee meets bimonthly to work on safety and quality of life issues for juveniles in the neighborhoods of City Heights. The committee is chaired by The Institute for Public Strategies and attended by representatives various community groups, San Diego Unified School District, the San Diego Police and San Diego City School's Police Department.

**Cultural Arts Alliance** – This program is designed to provide early intervention to deter juvenile offenders from further involvement in the justice system and to reduce the costs that are associated with the prosecution of the offender. The emphasis is on skill development and positive choices to assist the juvenile from further involvement in the Juvenile Justice System.

On June 8th, the first Art Alliance diversion class was conducted at Mid-City Division. Juvenile Administration and the Probation Dept. participated in this class. The class graduated August 3, 2016.

Juvenile Services annual training -On August 16, 2016, the Juvenile Administration unit presented the annual SDPD/ School PD/Probation Department training day. Multiple topics related to law enforcement and juvenile services were presented.

Juvenile Diversion – The Juvenile Administration unit works in an ongoing effort with multiple Community Based Organizations. It is designed to bring the latest and most updated Diversion programs to the San Diego Police Department. Diversion is set up for low level offenders to be an alternative to the juvenile justice system.

### **Community Involvement**

Junior Charger Training Camp (5) - Juvenile Administration worked in conjunction with Star/Pal to offer youth football camps at various locations.

Junior Padre Baseball Clinics (2) – Juvenile Administration worked in conjunction with Star/Pal to offer youth baseball camps at various locations.

Shop with a Cop (3) - The San Diego Sheriff's Department is the host agency for this year's annual charity event. SDPD's Juvenile Administration Unit is representing our department during monthly planning meetings with other county law enforcement agencies in preparation for this event. The annual Shop with a Cop event will take place on December 3, 2016. On September 14, 2016, a Shop with a Cop BBQ fundraiser took place at the La Mesa Police Department.



Teddy Bear Drive (3) - The Teddy Bear Drive is an annual county wide law enforcement community event to bring stuffed animals to children being treated at Rady's Children's Hospital. SDPD's Juvenile Administration Unit is representing our department during monthly planning meetings and fund raising events throughout the year. This year's 26<sup>th</sup> annual Teddy Bear Drive is scheduled for December 6, 2016.

School Safety Patrol Event – Juvenile Administration coordinates the School Safety Patrol (SSP) for the City of San Diego. 68 elementary schools with approximately 1,700 SSP members participate in this program. On September 25, 2016, Juvenile Administration coordinated the annual SSP day at the San Diego Padres baseball game for 1,068 SSP members and their guests. The SSP members were able to participate in the Kids Festival before the game and then run the bases after the conclusion of the baseball game.

True Blue Buddies - On August 22, 2016, Juvenile Administration participated in the True Blue Buddies program at Porter Elementary School. The program is designed for underserved students in the 3<sup>rd</sup> through 5<sup>th</sup> grade within the San Diego Unified School District. True Blue Buddies is a yearlong mentorship that includes various events over the school year, educational workshops and holiday gatherings. The primary goal of the mentorship program is to provide support through small group mentoring, as well as to facilitate and build positive relationships with Police Officers at an early age. In this 2<sup>nd</sup> annual event, students were treated to a Back-to-School shopping spree. Students received a \$100 Target gift card to spend on new clothes and shoes to start off the new school year as well as a brand new backpack. The event is being supported by the San Diego Unified School District's Children and Youth in Transition Program, San Diego Unified School Police and the College Grove Target store team.

National Night Out - On August 2, 2016, the Juvenile Administration unit participated in the National Night event at Colina Park. This is an annual community outreach to celebrate Neighborhood Watch and promote police and community partnerships.

Annual Surf Clinic – On August 19, 2016, the Juvenile Administration unit participated in the annual Star/Pal surf clinic at Coronado State Beach. This event provided 60 underserved youth the opportunity to learn how to surf.

9-11 Ceremony – On September 7, 2016, the Juvenile Administration unit participated in the 911 ceremony at the City Concourse. This ceremony commemorated the 15<sup>th</sup> anniversary of the 911 terrorist attacks.
