

#### **Councilmember Gómez Presents HireSD Proposal**

On March 14, Councilmember Gómez presented HireSD, a community workforce development program which seeks to invest tax dollars into high paying, local jobs for San Diegans and promote higher wages for skilled and trained



construction workers. The proposal seeks to address income inequality in the City and provide San Diegans access to higher paying and higher quality jobs. The three main components of HireSD are a local hire program, a skilled and trained workforce program, and changes to the prevailing wage ordinace in the City.

# Councilmember Gómez said, "HireSD will require construction projects that receive City taxpayer dollars to hire San Diegans, pay workers a prevailing wage, and have a highly trained workforce."

The Budget and Government Efficiency Committee voted 3-1 to request a legal analysis from the City Attorney and request the Independent Budget Analyst prepare a report on the operational and fiscal impacts for the program. The item will be scheduled to return to the committee in the fall.

They do a lot to help our women locally and abroad and we thank them for what they do."
