Subject: Temporary Closure of Development Services Center at 101 Ash St.

The Development Services Center at 101 Ash St. will be closed for business starting on Tuesday, Jan. 21, with all services conducted by the Development Services Department (DSD) at this location being temporarily suspended, moved or provided online until further notice. Please check our website or email notification for the latest available information.

The temporary closure will remain in place for the safety of employees and customers after a recent inspection by the County found a pea-sized amount of fire-proofing material containing asbestos in an area not accessible to customers. The inspection results came after more than 235 air-monitoring tests at this facility since August confirmed that air quality was safe for occupants. Out of an abundance of caution, City leadership made the decision to temporarily close the building until effective mitigation efforts are completed.

During the temporary relocation of DSD staff, some development permit services will be suspended until further notice. These include:

- **Simple (No-plan Mechanical, Electrical, Plumbing) Permits:** Customers can apply in person at the Ridgehaven Office without an appointment. It is preferred that customers apply and pay for these permits <u>online</u>, which can be made 24 hours a day.
- Mobile Home Installation and Addition Permits
- Special Inspector/Lab/Agency Registration
- Meet with Inspectors: Meet with inspectors on a walk-in basis without an appointment, Monday through Friday, between 7:45 a.m. and 8:15 a.m. To schedule an appointment with an inspector, use the online DSD <u>Staff Directory</u>. Appointments are highly recommended.
