# Subject: Week of April 20 Summary of Department Operational Changes in Response to COVID-19

As the impact of the COVID-19 pandemic is continuously evolving, the Development Services Department (DSD) is making adjustments to how it provides essential City services to customers. These operational changes are fluid and may change daily, but help ensure the health, safety and well-being of customers and employees. DSD will send weekly emails with process updates posted on its <u>Operational Changes in Response to</u> <u>COVID-19 page</u> to subscribed customers.

Customers are encouraged to visit <u>sandiego.gov/dsd-covid19</u> to keep updated on the latest changes. Here is a summary of this week's service changes:

- **Payments:** Payment drop-offs can be made in the first-floor lobby of the <u>Development Services Center</u>, located at 1222 First Ave. All payments must be made out to "City Treasurer." - **Project Review Comments:** Customers can now review next-time document requirements for resubmittals and project review staff comments online on <u>OpenDSD</u>. Learn how.
- Planning Commission Meetings: The first virtual Planning Commission meeting took place on April 16, after previous meetings were suspended in response to the COVID-19 pandemic several weeks ago. The meetings are broadcast online and aired on CityTV on Cox Communications and Time Warner Cable Channel 24. Members of the public can now comment on an agenda or non-agenda item, using this webform.

- **Technical Advisory Committee (TAC) Meetings:** The next TAC meeting is scheduled for Wednesday, April 22, and you can <u>view the agenda online</u>. TAC members will participate by teleconference and/or videoconference. If you would like to comment on an agenda or non-agenda item, comments may be submitted using this <u>webform</u>. Staff is assessing alternatives to in-person attendance for participating in TAC meetings. Please visit the <u>TAC page</u> for updates.
- **Hearing Officer Meetings:** The next Hearing Officer <u>meeting will take place on</u> <u>Wednesday, April 22</u>. Instead of in-person attendance, members of the public may submit their comments online using this <u>webform</u>.
