#### **Grant Updates and Forecasting**

- <u>Federal Grant Opportunities:</u> Erich Yost, US HUD | This is a great time to begin planning which grants we want to pursue in the coming year since this is a slow time for grants.
- <u>EPA Local Foods Local Places TA:</u> Erich Yost, US HUD | This is an EPA and USDA sponsored technical assistance to help local partners develop a strategic plan to invest in neighborhoods and to support food systems. This is something the San Diego Promise Zone plans to pursue with interested members of this group.

- <u>Fresh Start</u>: San Diego for Every Child has connected with this organization which offers free reconstructive surgery for any infants, children, or teens.
- <u>Child and Youth Success</u>: This is an effort to organize at the City for children and youth.

- Champions for Health offers free flu clinics for anyone who does not have health insurance.

#### **Covered California** | Monica Leyva, Health Net LLC (<u>monica.leyva@healthnet.com</u>)

- Through the end of 2020, they will continue eliminating co-pays and authorization requirements for telehealth services.
- Extended special enrollment will be from November 1<sup>st</sup> to around December 15<sup>th</sup>
- COVID-19 related costs are waived for Medicare, MediCal, and CoveredCA members.



• The cost of Covered California is less than the cost of the penalty for being uninsured.

#### Más Fresco Digital Access & Utilization Survey Results | Kate Edra & Joe Prickitt, UCSD CCH

- This survey was inspired by a major shift in Más Fresco enrollee demographics during the pandemic due to a pivot from in-person enrollment efforts to digital enrollment efforts.
- <u>Survey Details & Results</u>
  - There were 591 survey respondents, all Más Fresco and CalFresh recipients
  - *How was internet accessed?* 88% with a smartphone; 43% with computers
  - How often was the internet accessed? 80% reported daily use
  - What internet platforms were most commonly used? Facebook, YouTube, WhatsApp
- <u>Next Steps:</u> The Más Fresco team has contracted with a marketing company and a communication platform to improve digital communications
