I hope you're doing well as our city continues to make progress on some of our biggest challenges. I wanted to give you an update on what we've been working on at City Hall.

March 9th City Council Meeting

Two important items from this week's Council meeting are highlighted below:

Resolution Condemning Hate and Extremism - On Tuesday Council unanimously passed my resolution condemning hate and extremism. Prejudice and violence will not be tolerated in San Diego.

Climate Equity Fund - This is an important step to create more equity in how we designate funds to prepare our city for increasingly extreme weather due to climate change. By creating a dedicated fund for projects in communities of concern, we're doing our part to decrease the impact on global warming in historically underserved neighborhoods. Increasing Outreach in Our Beach Communities

On Wednesday, in Ocean Beach, I joined Mayor Todd Gloria, PATH (People Assisting the Homeless) San Diego, the Regional Task Force on the Homeless & the San Diego Housing Commission to announce our new outreach plan to homeless San Diegans. Now, we'll have outreach workers all over the city, including our beach communities in District 2 - with a people-centered, neighborhood specific approach. This will have a positive impact on one of our largest and most complex challenges.

This Monday will be our first meeting of the City Council's new COVID-19 Response and Recovery Committee. This Committee is a key development in both getting our city through the health dangers of the pandemic and restoring our local economy. COVID-19 Information

San Diegans currently eligible for the vaccination include the groups below:

Phase 1A-Tier 1 Vaccinating NOW*

- Staff working in acute care, psychiatric, and [correctional facility hospitals](#)*
- Staff working in skilled nursing facilities, assisted living facilities, and similar settings
 - Also includes residents in these long-term care settings
- Paramedics, EMTs, and other staff providing emergency medical services
- Staff working in dialysis centers
- Staff working in behavioral health residential facilities
 - Also includes residents in these behavioral health residential facilities
- Vaccinators

Phase 1A-Tier 2 Vaccinating NOW*

- Staff providing intermediate care, for persons who need non-continuous nursing supervision, and supportive care
- Staff providing in-home health-care and in-home supportive services
- Community health workers, including promotores
- Public Health field staff
- Staff working in primary care clinics
- Staff working in Federally Qualified Health Centers
- Staff working in Rural Health Centers
- Staff working in correctional facility clinics
- Staff working in urgent care clinics
- Staff working in behavioral health non-residential or outpatient facilities
 - Also includes residents in these behavioral health non-residential or outpatient facilities

Phase 1A-Tier 3 Vaccinating NOW*

Other settings and healthcare personnel not identified in Phase 1A-Tier 1 or Phase 1A-Tier 2, including:

- Specialty clinics, [laboratory workers](#) **, dental/oral health clinics, pharmacy staff, and funeral workers and others.

Phase 1B Vaccinating NOW*

- Persons aged 75 years and older
- Persons 65-74 years of age
- Frontline essential workers at risk of exposure through their work in the following sectors: [Emergency Services](#) (including emergency operations workers, fire and law enforcement); [Childcare and Education](#); and [Food and Agriculture](#).

On Tuesday, March 16th, our community members who already deal with chronic health issues will be able to get appointments to be vaccinated. Those health conditions include:

Phase 1C*

- Persons 16-64 years old with one or more of the following health conditions:
 - Cancer, current with debilitated or immunocompromised state
 - Chronic kidney disease, stage 4 or above
 - Chronic pulmonary disease, oxygen dependent
 - Down syndrome
 - Immunocompromised state (weakened immune system) from solid organ transplant
 - Pregnancy
 - Sickle cell disease
 - Heart conditions, such as heart failure, coronary artery disease, or cardiomyopathies (excludes hypertension)
 - Severe obesity (Body Mass Index ≥ 40 kg/m²)
 - Type 2 diabetes mellitus with hemoglobin A1c level greater than 7.5%

If you're not yet eligible for the vaccination, please consider signing up for alerts from California's COVID-19 vaccine notification website. It's the easiest way to stay informed on when you're eligible. [Click here to sign up.](#)
